

NOTICE OF DECLARATION OF MANDATORY ANNEXATION

Whereas, on the 24th day of June 2010, the State Board of Education voted to dispense with and mandatorily annex all of the Watson Elementary School District (48C056), of McCurtain County, Oklahoma, to the district indicated below, pursuant to the provisions of Oklahoma State Statutes. (70 § 7-101.1)

Whereas, said mandatory annexation was approved by a majority of the State Board of Education members meeting in Oklahoma City, on June 24, 2010, to annex the entire Watson Elementary School District (48C056), to the Smithville Independent School District (48I014), of McCurtain County, Oklahoma, as prescribed by law.

All of the Watson Dependent School District (48C056) territory, facilities, assets, liabilities, and equipment will become the property of the Smithville Independent School District (48I014), of McCurtain County, Oklahoma.


