


ADEQUATE YEARLY PROGRESS

- Required by No Child Left Behind
- Measures all students
 - Total group
 - Subgroups
- Focus on four criteria:
 - 1. Math achievement
 - 2. Reading achievement
 - 3. Participation in state testing
 - 4. Attendance and graduation rates

For each student group, did the site or district meet the required performance targets?





SAFE HARBOR

- Safe Harbor allows for alternate ways for sites and districts to meet the reading and math performance targets. The criteria are based on sufficient progress from one year to the next.
 - Percentage of tested students in that student subgroup below the satisfactory performance level decreases by 10 percent, or
 - Students in the subgroup demonstrate a ten percent increase in the difference between the previous year's math and/or reading/language arts API score(s) and the maximum score

GRADUATION RATE FOR HIGH SCHOOLS AND DISTRICTS

- Sites and districts must graduate 67.8% of students or improve by 10% of the difference between the previous year's rate and 100%
 - For example, if a site's graduation rate last year was 60%. The site must increase the rate by
 .10 (100-60) or 4%. So to meet the criteria this year's graduation rate needs to be 64%

ATTENDANCE RATE ELEMENTARY AND MIDDLE SCHOOLS

- Attendance rate benchmarks for the 2010-2011 school year:
 - A school site/district must meet or exceed an attendance rate of 91.2%.

SCHOOL IMPROVEMENT IDENTIFICATION

- Sites and Districts are identified as "In School Improvement" when they do not make the benchmark for Adequate Yearly Progress for two consecutive years.
 - Reading,
 - Math,
 - Attendance or Graduation Rate, or
 - 95% Percent Tested.

SCHOOL IMPROVEMENT IDENTIFICATION

- Adequate Yearly Progress must be made by all students and by subgroups of students:
 - Regular Education,
 - Individual Education Plans,
 - English Language Learners,
 - Ethnic Groups, and
 - Economically Disadvantaged
- Districts are identified when they do not make Adequate Yearly Progress across all grade spans.


