Moving Forward:

Site visits from the Office of School Support (OSS) are well underway and we have had the opportunity to meet and begin working with so many wonderful educators from around the state. With each site visit comes a part in the conversation where the School Support Specialist is asked "How do I get off this list?!!" This is the one question asked by almost every instructional leader who is working with a school that has been designated as Priority or Focus. The OSS certainly does not have a one size fits all formula for academic success. We recognize and celebrate that each school is unique in its educational culture and climate. However, what we do know is "What Works in Oklahoma Schools," a research project conducted in schools throughout Oklahoma from 2009-2011 by Dr. Robert Marzano. From this work we are excited to bring back to the Office of School Support the Oklahoma Nine Essential Elements for School Improvement. The Oklahoma Nine Essential Elements provide schools with a comprehensive framework of best practices, supports and resources as well as the opportunity for continuous school improvement for all schools - urban, suburban, rural; large or small; high performing or low achieving. These essential elements focus on improving student learning by preserving the goal of learning as the fundamental purpose for academic achievement, creating collaborative cultures that support a learning environment and by focusing on results and data driven decisions through collaborative leadership. It is through these pillars of school improvement that districts will be able to build capacity, provide support and resources and implement best practices that will improve the academic achievement for all students.

The Office of School Support will be providing webinar training and professional development in the upcoming months on the Oklahoma Nine Essential Elements. Information will be made available via email, posted on our website and in our monthly newsletter. 

REMINDER

School Improvement Status Report (SISR)

As you are aware, designations for SY15 have not been released. However, many have expressed an interest in getting started on the SISR Report. When you visit the SISR site, any data that is available is based on SY14. Please know, once the A-F Report Card appeals and verifications have been processed and finalized, SY15 testing data will be loaded and pre-populated into the SISR Report. The program is available for sites to begin loading benchmark data for the fall semester. However, the Consultation, Baseline and Initial Report "close date" will not be established until new designations for SY15 are final. We most certainly will allow ample time for any school new to designations to complete these reports as well as schools with a previous designation.
