The Office of School Turnaround is excited about the upcoming year and the opportunity to serve schools from around the state. One of the goals for our monthly newsletter is to provide you with a preview of information and any upcoming events. With that said, the OSDE is anxiously awaiting word from the USDE regarding the approval of the Oklahoma ESEA Flexibility Waiver. We should receive news before the first of August but wanted to give you a preview of some of the proposed new conditions and requirements.

Beginning with the 2015-2016 school year, Graduation Rate will be reflected in the Bonus Point section of the A-F Report Card and in the Annual Measurable Objects (AMOs) as required by USDE. High schools with a graduation rate in the bottom 20% of all high schools will receive a Focus Designation. Based on this year's data, this would include any school with a graduation rate of 81% or below. In addition, high schools that have a subgroup with a graduation rate below the national average will receive a Targeted Intervention Designation. Based on this year's data, the averages for each subgroup in Oklahoma are well above the national average.

In regards to schools who have had a designation of Priority or Focus for more than three years, beginning in 2015-2016, the principal and superintendent of these schools will be required to attend 15 hours of professional development with an emphasis on school improvement strategies. The OSDE will be working with CCOSA and the OSSBA to ensure a variety of opportunities are available to you. For administrators who know they will need to fulfill this requirement, [EngageOK](#) will be the perfect opportunity to begin earning these hours.

Schoolwide School Sites Exempt from “Supplement not Supplant” Rule

**Federal Register 69, Vol. 69, No. 127 /
Friday, July 2, 2004/Notices**

Under these notices, the U.S. Secretary of Education authorized a Schoolwide School Site be exempt from complying with many statutory or regulatory provisions of those programs, if the intent and purposes of the programs are met in the Schoolwide Program. A School Site operating a Schoolwide Program is **NOT** required to demonstrate that

the services provided with Title I, Part A funds are supplemental to services that would otherwise be provided.

Please note that “District Level” expenditures are not exempt, because the “District Level” cannot be in Schoolwide status. MAKING THE GRADE

Wynnewood – Priority to High Academic Progress: Central Elementary School’s Educational Journey

The passion in Tammy Grove’s voice is evident when she describes the educational journey made by her teachers and the children of Central Elementary School, Wynnewood Public Schools, Wynnewood, Oklahoma.

Grove serves as the principal of this Pre-Kindergarten through 4th grade site located in Garvin County. This elementary site houses about 360 students. An estimated breakdown of the demographics is 64% Caucasian, 12% Native American, 10% Hispanic, 10% African-American and the remaining 4% represented by Asian, Two or More Races, and/or other ethnicities.

Central Elementary School was designated as a priority school with a 59 F on the 2013 A-F Report Card. Immediately, Grove and her teachers and staff members began a collaborative process to determine instructional needs, identify at-risk students, and to provide appropriate, purposeful interventions. The 2014 A-F Report Card grade of an 85 B reflects their hard work and dedication to improve student achievement.

Below are a few of the steps that Central Elementary School implemented that moved the school from priority designa-

tion to being recognized as a “High Academic Progress” site:

- Protected Instructional Time – Policies are in place to eliminate distractions;
- Master Schedule – 90 minute blocks are scheduled for language arts;
- Team Collaboration – Instructional teams meet weekly to discuss and develop strategies based on current student data, to ensure alignment to Oklahoma state standards, and to develop pre- and posttests;
- School Effectiveness/Environment – Response to Intervention (RtI) and Positive Behavioral Interventions and Supports (PBIS) models are implemented;
- Parental Engagement – Regular communication with parents and patrons via a variety of modes to reach all stakeholders.
