CHAPTER 10. STATEWIDE VIRTUAL CHARTER SCHOOLS
SUBCHAPTER 1. GENERAL PROVISIONS

- a. **What is the purpose of the proposed rule change?**
The purpose of the proposed new rule at 777:10-1-2 is to define terms used in rules pertaining to the statewide virtual charter school facilities and face-to-face instruction at charter school sites. The proposed rule also defines what constitutes a statewide virtual charter school subject to the regulations of Title 777. The proposed permanent rule, if adopted, will replace the emergency rule currently in effect.
- b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**
The proposed changes will affect statewide virtual charter schools and their governing bodies, employees, enrolled students, and parents/legal guardians of enrolled students.
- c. **What classes of persons will benefit from the proposed rule change?**
The proposed changes will benefit statewide virtual charter schools and their governing bodies, employees, enrolled students, and parents/legal guardians of enrolled students.
- d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**
The agency does not anticipate any economic impact upon affected classes of persons or political subdivisions as a result of implementation of the proposed rule change at this time.
- e. **What is the probable cost to the agency to implement and enforce the proposed rule change?**
