SUBCHAPTER 13. STUDENT ASSESSMENT

- a. **What is the purpose of the proposed rule change?**
The proposed changes to 210:10-13-22 revise the formula used to calculate the school report card grades under the A-F grading system established at 70 O.S. § 1210.545. The amendments to the rule are necessary to implement revisions to the formula resulting from amendments to 70 O.S. § 1210.545 during the 2013 regular legislative session (HB 1071, HB 1658) and a new law codified at 70 O.S. § 3-145.6, which directs how virtual education providers are to be considered. The proposed changes also add provisions addressing calculation of report cards for small schools for federal reporting purposes. The proposed permanent rule, if adopted, will replace the emergency rule currently in effect.
- b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**
The proposed changes will affect public school students and their parents/legal guardians, public schools, and public school districts.
- c. **What classes of persons will benefit from the proposed rule change?**
The proposed changes will benefit public school districts, public schools, public school students and their parents/legal guardians by clarifying the bases upon which their schools and school districts are held accountable for public school student achievement.
- d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**
The agency does not anticipate any economic impact upon affected classes of persons or political subdivisions as a result of implementation of the proposed rule change at this time.
- e. **What is the probable cost to the agency to implement and enforce the proposed rule change?**
