

NOTICE OF DECLARATION OF MANDATORY ANNEXATION

Whereas, on the 26th day of May 2011, the State Board of Education voted to dispense with and mandatorily annex all of the Boynton-Moton Independent School District (51I004), of Muskogee County, Oklahoma, to the districts indicated below, pursuant to the provisions of Oklahoma State Statutes. (70 § 7-101.1)

Whereas, said mandatory annexation was approved by a majority of the State Board of Education members meeting in Oklahoma City, Oklahoma, on May 26, 2011, to annex the entire Boynton-Moton Independent School District (51I004) to the Haskell Independent School District (51I002), of Muskogee County, Oklahoma, and to the Midway Independent School District (49I027), of McIntosh County, Oklahoma, as prescribed by law.

All of the Boynton-Moton Independent School District (51I004) Territory is to be mandatorily annexed to:

All of the Boynton-Moton School District property, facilities, assets, liabilities, debt, and equipment, etc., known or unknown, will be divided equally between the Haskell School District and the Midway School District, per attached Annexation Agreements.



## ORDER OF MANDATORY ANNEXATION

Whereas, on the 26th day of May 2011, the State Board of Education voted to dispense with and mandatorily annex all of the Boynton-Moton Independent School District (51I004), of Muskogee County, Oklahoma, to the districts indicated below, pursuant to the provisions of Oklahoma State Statutes. Whereas, said annexation was approved by a majority of the State Board of Education members meeting in Oklahoma City, Oklahoma, on May 26, 2011, to mandatorily annex the entire Boynton-Moton Independent School District (51I004), of Muskogee County, Oklahoma, to the Haskell Independent School District (51I002), of Muskogee County, Oklahoma, and the Midway Independent School District (49I027), of McIntosh County, Oklahoma, as prescribed by law.

All of the Boynton-Moton Independent School District (51I004) territory is to be mandatorily annexed as designated to:

All of Sections 10, 11 and 12 in Township 14, Range 15; And All of Sections 4, 5, 6, 7, 8, 9 and the Northwest  $\frac{1}{4}$  of Section 10, the West  $\frac{1}{2}$  of Section 15, and the West  $\frac{1}{2}$  of Section 3, and All of Sections 16 and 17 in Township 14, Range 16; And the Southeast  $\frac{1}{4}$  of Section 31, the South  $\frac{1}{2}$  of Section 32, and the South  $\frac{1}{2}$  of Section 33, part of the Northeast  $\frac{1}{4}$  of Section 33 East of the Coody Creek, part of the Southeast  $\frac{1}{4}$  of Section 28 East of Coody Creek, the South  $\frac{1}{2}$  of the Northeast  $\frac{1}{4}$  of Section 27, and the North  $\frac{1}{2}$  and Southwest  $\frac{1}{4}$  of Section 34, the North  $\frac{1}{2}$  of Section 35, and the North  $\frac{1}{2}$  of Section 36, and all of Sections 24, 25, 26, and the East  $\frac{1}{2}$  of Section 23, and part of Section 14 Southeast of River, and part of Section 13 Southeast of River, in Township 15, Range 16; And Part of Section 7 South of River, Part of Section 8 South of River, Part of Section 9 South of River, Part of the Southwest  $\frac{1}{4}$  of Section 3 South of River, and the West  $\frac{1}{2}$  of Section 10, the West Half of Section 15, and All of Sections 16, 17, 18, 19, 20 and 21, and the West  $\frac{1}{2}$  of Section 22, the West  $\frac{1}{2}$  of Section 27, and All of Sections 28, 29 and 30, and the North  $\frac{1}{2}$  of Sections 31, 32 and 33, and the Northwest  $\frac{1}{4}$  of Section 34, in Township 15, Range 17.




