- ❖ Alternative Education Evaluation Rubric —The rubric is about the quality of the program. The checklist is the compliance piece, required by law.
 - Section Changes-from Appropriate Program design to Serve At-Risk Students to Program Information
 - New logo
 - Total points out of 90 (from 95)
 - Rating ranges changed
 - Non-compliant 0-33 (23 max +10) Effective 34-75 (65 max + 10) HE 76-90
 - 17 criteria changed to 16 criteria
 - Section Changes from Faculty Selection to Faculty Selection and Development
 - Changed heading to include Development
 - Moved Certification to Checklist
 - Language on PD focuses on delivery and access
 - Professional Learning and Staffing language combined

- Scoring range revised due to change indicators options
- Intake and Screening
 - Special Ed from Program Design changed to Population Representation and includes suspension placement
 - Risk of students focuses on use of assessment vs served
 - Participants moved under risk of students
 - Discipline language reflects addressing discipline
 - Program choice changed to "student choice in program"
 - Scoring range revised due to change indictors options
- State and Local Collaboration
 - Added in person or virtually to EF and HE
 - HE rating includes multiple partners
- Individualized Learning Plans
 - Heading changed from ICAP
 - Development/Updated changed to Management and Monitoring
 - HE rating includes student articulation of plans
 - All ratings language includes "learning plans" vs "graduation"
 - Career interest inventory HE rating includes virtual
- Individualized Instruction
 - Effective rating includes teacher-led; HE rating includes student-led
 - HE rating emphasizes student interests
- Effective Instruction
 - State standards moved to checklist
 - Record keeping Effective includes student communication; HE is bi-weekly
 - Interaction Effective rating is daily with students; HE may include community partners
 - Ryan Abernathy- resource added: 2 question evaluator for food

 - Student Progress changes suspension to discipline and includes sample measures
 - Progress title includes frequency and scale defines frequency
 - Rigor elements defined; state removed to also include any assessment
 - Response to Intervention changed to Interventions that include RTI and PBIS
- Counseling and Social Service
 - HE rating specifies certified/licensed for consistency
 - Social services changed to Extent of Services; HE rating includes wrap-around
- Life Skill Instruction
 - HE rating includes frequent opportunities beyond classroom
- Arts Education
 - Curriculum ratings gives "arts" examples
 - Presentation language changed from "provided with" "to evidence-based

- Enrichment HE rating expanded
- Enrichment and Presentation switched
- Program Evaluation
 - Title Self-Evaluation change- Program Evaluation
 - Goal and Objective moved to first; reviewed and analyzed add; twice/year added for Highly Effective(HE)
 - State reporting combined to include Financial and other reports; rating increases by quantity and timeliness
 - Feedback includes use of data and HE requires evidence of changes based on data
 - Exit Survey moved above
