### Alternate ACCESS Accountability and Reclassification

#### Background

- In 2024, an updated version of the WIDA Alternate ACCESS was administered to qualifying students
- This updated assessment corresponds to the WIDA ELD Standards Framework 2020 Edition and is aligned to WIDA's new Alternate English language proficiency descriptors (Alt ELPDs)
- Therefore, a standard setting is occurring for Alternate ACCESS in the summer of 2024



- WIDA will be rescaling Alternate ACCESS
- WIDA will supply a concordance table to relate the 2024 scale scores to the 2023 scale scores and proficiency levels along with the file of 2024 Alternate ACCESS scale scores
- Concordance tables are not perfect; they include measurement error, simply meaning imprecision










 There is a likelihood that the concordance table will have one-to-many or many-to-one relationships between scale scores






1b: One 2023-24 score to many 2022-23 scores






1a: Many 2023-24 scores to one 2022-23 score

#### **Lowest Scale Score Rule**

#### **Pros**

 More Alt ACCESS test takers might meet their growth targets and/or exit

#### Cons

 Alt ACCESS test takers might exit before they are truly proficient



#### **Highest Scale Score Rule**

#### **Pros**

 Variability is expected among Alt ACCESS test takers in meeting growth targets due to the range of disabilities and whether they are permanent or temporary

#### Cons

 Less Alt ACCESS test takers might not meet their growth targets and/or exit



#### Recommendation and Rationale


#### We are recommending the Lowest Scale Score Rule

#### **Rationale**

- New test items are more challenging, and the level of academic language expected of students on the new assessment is greater than the previous test
- 6% of Alternate ACCESS test takers met their growth targets in 2023 compared to 16% of ACCESS test takers
- Might increase equity based on these percentages

# Part 2 Alternate ACCESS Growth Calculations



#### Background

- Making progress for the Alternate ACCESS assessment is defined by improving the scale score in all domains
- Please note that Alt ACCESS test taker calculations do not have years to exit factored in as do ACCESS test taker calculations



### Suggested Alternate ACCESS Growth Calculations

- For a student participating in all four, three, and two domains of the Alternate ACCESS, growth should be considered as increasing in the overall scale score by one or more points.
- 2. For very rare, individualized circumstances in which a student participates in one domain of the Alternate ACCESS, that domain scale score should be considered as the overall scale score. Growth should be considered as increasing in the overall scale score by one or more points\*.

\*Please note that for an Alternate ACCESS test taker participating in one domain to auto exit or band exit, they must continue to be exempted from all domains except one and meet exit criteria. If they are able to participate in more domains in the future, this will reset the exit criteria.




#### Rationale

#### The suggested Alternate ACCESS growth criteria would:

- Align Alt ACCESS growth calculations to ACCESS growth calculations by using scale scores
- Make growth more equitable
- Provide a pathway of exit for ALT ACCESS test takers exempted from three domains
- Only six states have publicized their Alt ACCESS growth calculations; five of which use growth to target models like the one we have mentioned

#### **Considerations for 2025**

- After the standard setting in July 2024, WIDA recommends re-examining reclassification criteria for Alternate ACCESS
- New proficiency level designations and proficiency level cut scores will be set
- Should new growth expectations be required, a re-examination of including a timeline to proficiency may also be explored
