## Resolution presentation and recognition of Jessica Eschbach, 2021 Teacher of the Year (TOY)

Superintendent Hofmeister recognized Jessica Eschbach, Oklahoma's 2021 Teacher of Year who began her 1-year tour of duty on July 1 as the Ambassador for Teachers in Oklahoma.

Ms. Eschbach thanked board members for allowing the opportunity to represent Oklahoma and assuring every student has every opportunity to succeed. She partners with the SBE goal and is excited where the journey takes her. It is her hope to make Oklahoma teachers proud in the national competition, continue outreach and support to ensure all teachers have what they need to service Oklahoma students.

Superintendent Hofmeister said the 2021 Legislative Red Banner Book of 2021 Legislation were available and includes bills passed into law that impact Oklahoma. Updated on a notification to withdraw the approved Administrative Rules for House Bill 1775 due to technical reason. Instructions were received to remove an electronic version from the Secretary of State website, correct errors, and resubmit. A special SBE meeting will be scheduled to consider the corrected version, revote for resubmission and at that same time hiring a new board attorney. With no other required changes school districts in the meantime must follow the guidance until that is completed.

We have learned this morning, an eighth-grade student passed away due to COVID, and a teacher passed a few days ago. Sadly, the Delta variant is more contagious and is surging throughout communities and schools are no exception; and are dealing with numerous positive cases and students/staff quarantines and school restrictions. The most important thing is protecting their health and well-being, understand this is not like 2020 and we need to take it very seriously.

Superintendent Hofmeister and Tiffany Neill, Deputy Superintendent of Curriculum and Instruction overviewed the Return to School Guide/website offering students, schools/leaders and families with support structures that included a two-prong approach to support, statewide initiative, platforms, five support categories, guidance documents, relief fund frameworks, higher education partnerships, professional development academies, Teach for America partnership grant, and YMCA community outreach site recipient.

Board members discussed and asked questions regarding Consent Docket waiver requests on:

- 6(a) Abbreviated School Day-Little Axe Public Schools waiver requesting less than 4 hour 15 minutes minimum for alternative education; clarity need on reasons applicants requesting less days and/or time and concern alternative education night program needed to accommodate students.
- **6(b) Cooperative Agreements-Bowlegs Public Schools** identifying serving less than ten (10) students within proximity to a cooperating school requested three hours and 30 minutes alternative time, four days per week. Board members requested to provide number of school districts with Cooperative Agreements.
- 6(d) Library Media Specialists-Edmond Public Schools-Edmond Memorial High School waiver request due to not having a credentialed librarian

Ryan Pieper, Executive Director of Accreditation, said the abbreviated school day waiver requesting less hours for alternative education program are often accommodating student work schedules and to obtain career tech certifications. Program types are examined for effectiveness, graduation rates, testing and how a school finds what works for them and student to be effective. A list of cooperative agreements will be sent to board members. The librarian shortage is similar to the emergency certification wavier where individuals have not completed the certification program pathway, as well as is more difficult to staff in more rural areas.

Board member Smith said for a lot of reasons, for the Board and the Department as a whole, moved to formally call on President of the Western Heights School to resign for many reasons, one of which is his relationship with Superintendent Barnes, and the use of taxpayer dollars.

I question why they need twice as many attorneys as the entire State Department of Education. There is unbelievable talking about all of the other reasons, but I would also like to call on the parents at their Western Heights School District to continue to put as much pressure on him as possible. He is a cancer in our midst and needs to be removed as soon as possible. I regret we cannot do more today.

Superintendent Hofmeister said no decisions made during the Executive Session. Those included in the executive session were Legal Counsel, Chief of Staff and Dr. Robyn Miller.

She advised the situation at Ninnekah Public Schools is being closely followed and the legal services and Title IX offices have been conducting on-site investigations. During the executive session the SBE was updated on the SDE process preparing to take the next steps regarding the school district's accreditation as well as other intentional certification suspensions and revocations. While we are unable to take specific action today due to that process, procedures, timelines, and statute requirements, we feel it is still important to address the general public and the Ninnekah community that we hear them and are supportive of all of those who have been harmed in any way, that they come forward, and that we also want to ensure there is a culture that openly investigates any type of report or allegation and that is taken very seriously.

Board member Bobek concurred the SBE has taken the horrible situation seriously for those who have been victimized. There is an investigation and next steps will be coming as we are taking this very seriously to help protect those in the community.

Board member Smith moved to accept the Hearing Officer's orders to revoke teacher certificates and teacher numbers for **Aaron Hernandez and Bart Daniel**. Board member Hernandez seconded the motion: The motion carried with the following votes: Mr. Smith, yes; Ms. Williams Bradley, yes; Ms. Hernandez, yes; Mr. Flanagan, yes: Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

Board member Smith moved to issue emergency orders to summarily suspending the teacher certificates and certificate numbers of **Ronald Arthur**. Board member Monies seconded the motion. The motion carried with the following votes: Mr. Smith, yes; Ms. Williams Bradley, yes; Ms. Hernandez, yes; Mr. Flanagan, nay: Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.
