CALL TO ORDER AND ROLL CALL

State Superintendent Joy Hofmeister called the State Board of Education regular meeting to order at 10:05 a.m. Ms. Cheadle called the roll and ascertained there was a quorum.

Superintendent Hofmeister welcomed everyone to the meeting of the State Board of Education.

Superintendent Hofmeister recognized Les Rohrer, Director, Data Literacy-Accountability as the December employee for the month.

Superintendent Hofmeister updated on hosting the Fourth trauma summit (virtual conference) "Awareness to Action: Creating Trauma Informed schools Through Multi-Tiered Systems of Support" February 15, 2021 and registration available on SDE website.

Presentation of ELEVATE chronicles of the positive, inspiring and innovative matters in Oklahoma public Schools

Superintendent Hofmeister highlighted Elevate Series presentations by videographer Craig Gaglio and Broken Arrow Public Schools therapy dog/student interaction program; and Shawnee Early Childhood Center "Empowering Littlest Learners."

Ryan Pieper, Executive Director of Accreditation and Board members discussed and asked questions regarding Consent Docket 5 (a) **Abbreviated Day** waiver request commending **Watonga Public Schools** on detailed application and requested **Stigler Public Schools** provide further program details on virtual alternative program additional flexibility.

Consent Docket 5(b) **Cooperative Agreements** waiver request commended **Grandview Public Schools** on good detailed application.

Consent Docket 5(c) **Library Media Services (LMS)** waiver requests pulled for **Gracemont Public Schools** to require more specifics and **Albion Public Schools** to present library schedule and regularity for making teachers responsible for library to be open; request justification for **Wewoka Public Schools** three-year waiver per COVID protocol for library book checkouts and recommended one year waiver only.

Board member Monies moved to deny the LMS waiver requests for **Gracemont** and **Albion Public Schools**, and grant a one-year LMS waiver for **Wewoka Public Schools**. Board member Bobek seconded the motion. FEDERAL PROGRAMS & FINANCE

Payment of federal program claims - Approved

Monty Guthrie, Deputy Superintendent presented federal program claim payment request for **Earlsboro Public School District** of CARES Act federal funding. The school complied with procedure and provided the required good cause letter of explanation and approval is recommended.

Board members discussed claim invoices for CARES Act funding expenditures, application timeline/submissions, carryover funds, and program waiver process.

INSTRUCTION

Focused Field of Study for an Entrepreneurship Academy at Francis Tuttle Technology Center Academy - Approved

Levi Patrick, Assistant Deputy Superintendent, Curriculum & Instruction, presented a recommendation request to approve a focus field of study for an entrepreneurship academy application for entrepreneurship at Francis Tuttle Technology Centers. Francis Tuttle provided all required application content and met qualification for a first entrepreneurship academy this fall. The new academy will be located in Edmond. Jared Scott, Assistant Superintendent, Francis Tuttle was present.

Board members discussed and asked questions regarding monitoring and success of existing programs, studies, and graduates; request State Career and Technology Education Board provide program and student success update.

Board member Bobek moved to approve the France Tuttle Career and Technology focus field of study request. Board member Monies seconded the motion. LEGAL SERVICES/STATE BOARD OF EDUCATION OFFICE

Teacher Leader Effectiveness for the 2020-21 school year - Approved

Mr. Clark advised that the State Board of Education adopted criteria for the evaluation of certified educators (teachers and administrators) and recommended providing a one-year option to waive the qualitative component for the 2021 school year and requires districts continue submitting assurance documentation for review and approval. Mr. Clark reviewed the annual evaluation system, qualitative assessment, teacher objective observance, measurable characteristics, classroom practices and student performance; and administrator site practices/management and student performance; also includes professional development (PD) individualized program or PL Focus for teachers and administrators.

Board members discussed and asked questions regarding continual teacher evaluation, virtual teaching evaluation consideration, PL Focus component inclusive of virtual student engagement and professional learning; qualitative component waiver timeline through 2021 school year; SDE virtual environment content specific trainings/resources, EngageOK virtual PD and Network of Learning/support, EDGE Platform PD sessions and Project ECHO.

Board member Bobek moved to approve the waiver request. Board member Williams Bradley seconded the motion. The motion carried with the following votes: Ms. Hernandez, yes; Ms. Williams Bradley, yes; Mr. Flanagan, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

Statewide System of Student Assessments and the statewide Accountability system (Oklahoma School Report Cards) - Approved

Maria Harris, Deputy Superintendent of Assessment and Accountability, presented a recommendation request to suspend the statewide student assessments and accountability system for the 2020-2021 school year.

Ms. Harris and board members discussed and asked questions regarding importance and purpose of assessments, components, federal and state student assessment requirements and effects of no assessments performed for 2019; effects of school accountability COVID-19 disruptions, transparency, data collection, report card labels, difference of academic growth indicator calculation, academic achievement looks different, and accountability system's numerous variable and moving pieces, reliability and 2022 valid, accurate reporting; clarity on disentangling accountability and assessment system, student learning focus, 2021 spring assessment and report schedule.

Board member Williams Bradley moved to suspend the issuance of State of Oklahoma report cards for the 2020-2021 school year. Board member Flanagan seconded the motion. The motion carried with the following votes: Ms. Hernandez, yes; Ms. Williams Bradley, yes; Mr. Flanagan, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

Cardiopulmonary Resuscitation (CPR) for the 2021 school year 70 O.S. § 1210.199 – Approved

Mr. Clark presented a waiver request recommending waiving the Cardiopulmonary Resuscitation (CPR) and course completion requirements for students prior to graduation for the 2020-2021 school year. In March 2020 the SBE approved a deregulation waiver and provided school districts flexibility due to the COVID-19 pandemic and nature of the CPR course involvement.

Board member Monies moved to approve CPR waiver request for the 2020-21 school year. Board member Bobek seconded the motion. The motion carried with the following votes: Ms. Hernandez, yes; Ms. Williams Bradley, yes; Mr. Flanagan, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

(Superintendent Hofmeister called for a recess at 12:03 p.m. and resumed at 12:22 p.m.)

Lori Murphy, Assistant General Counsel, presented a request to adopt the following permanent rules:

Board member Monies moved to adopt the permanent rules. Board member Bobek second the motion. The motion carried with the following votes: Ms. Hernandez, yes; Ms. Williams Bradley, yes; Mr. Flanagan, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

Report by Sovereign Community School accreditation, audit, finance, operations and governance of the school - Approved

Mr. Clark presented an overview of the SBE November 12, 2020 terms of probation that included Sovereign Community School (SCS) charter school fiscal management plan, incurred debts to Santa Fe South Development Corp, Oklahoma Teacher Retirement System, and other outstanding obligations; required school board and governing board independent review and capacity examination; OSDE reporting compliances, all reconciled financials completed and repayment timelines; current board, teacher and staff resignations; improved communications and cooperation.

(Board member Hernandez left the meeting at 1:00 p.m.)

Matt Wilson, Superintendent, Sovereign Community School reported current occurrences of position cuts, staff resignations, COVID-19 interruptions and impacts; low student moral and transfers; financial forecast, future student enrollment, and SBE authorizer obligations.

Board members asked questions and discussed sustainability and termination timeline; graduation requirements/credits, student transfers; and school closure timeline.

Mr. Clark said as a charter sponsor advised on steps and procedure prior to a Notice of Proposed Termination would include providing evidence for no closure, a required due process public hearing within 90 days, termination timeline, loan repayments and reconciled finances, and school closure schedule/planning.

Board member Williams Bradley moved to begin the 90-day window to have the hearing and to declare next steps for the status of opening the school. Board member Bobek seconded the motion. The motion carried with the following votes: Ms. Williams Bradley, yes; Mr. Flanagan, yes; Ms. Monies, yes; Mr. Bobek, yes; and Superintendent Hofmeister, yes.

Board members granted next step conditions to allow extended time for local board participation and fundraising, monthly reporting required throughout the 90-day window; move forward with proposed termination steps and scheduling a March 2021 hearing date.

Board member Bobek moved to accept the **Hearing Officers** proposed findings of fact, conclusions of law and orders to revoke the teacher certificates and certificate numbers of **Joyce M. Churchwell** and **Jayson D. Larremore**. Board member Bradley seconded the motion. The motion carried with the following votes: Ms. Williams Bradley, yes; Mr. Flanagan, yes; Ms. Monies, yes; Mr. Bobek, yes; and Superintendent Hofmeister, yes.

Mr. Clark updated Board members on receiving the Attorney General Opinion formal opinion request regarding Lindsey Nicole Henry (LNH)-Consent Docket item 5(f), implementation, rulemaking process and procedure explained by Lori Murphy, Assistant General Counsel.
