State Superintendent Joy Hofmeister called the State Board of Education regular meeting to order at 9:30 a.m. and welcomed everyone to the meeting. Ms. Cheadle called the roll and ascertained there was a quorum.

Superintendent Hofmeister led Board Members and all present in the Pledge of Allegiance to the American Flag, a salute to the Oklahoma Flag, and a moment of silence.

STATE SUPERINTENDENT

Information from the State Superintendent

Superintendent Hofmeister said "engageok ON THE ROAD" conferences begin July 18 and continue through July 28. Conference locations include Edmond, Broken Arrow, Lawton, Durant, Woodward, and Sallisaw.

The new federal *Every Student Success Act* (ESSA) education law requires a state plan with stakeholder feedback. The ESSA replaced No Child Left Behind education legislation. Conference participants will be provided information for discussions during the conferences.

School districts received communications regarding House Bill 3218 requirements, assessments and accountability in the A-F Report Card grading and how the bill impacts the 2016-17 school year. The bill repeals the end-of-instruction (EOI) test and opens the door for a replacement of a higher value tool, reducing overall number of tests, and reducing focus on tests.

Superintendent Hofmeister said Quartz Mountain celebrated the 40th anniversary of the Oklahoma Arts Institute. Oklahoma students are selected to participate in two-week studies with world renowned experts in various subjects. The final presentations are scheduled this coming weekend.

The K-8 school district can financially support the expansion; community supports bond issues, and has a complete master and long term plan.
