# CLASS Grant 1.0 Recipients



- 100% of Oklahoma counties received grant funding.
- 85% of Oklahoma districts had at least one teacher awarded.
- 93% of classroom teachers received grant supplies within 7 days.
- 99% of classroom teachers received grant supplies within 30 days.

# Please remember...

- **PRIOR** to the teachers' submission, the site or district administration should approve each grant. By submitting a project, teachers acknowledge responsibility for meeting district guidelines and state laws.
- **ALL** items received become the property of the school district and should be tracked (except consumables) per federal guidelines.
- **Whitelist** the DonorsChoose URL to make communication between the teacher, district, and DonorsChoose much faster and easier.



# CLASS Grant 2.0 will:

- Include all full-time PK-12 teachers, including school counselors, reading specialists, media specialists, speech pathologists, physical therapists, and occupational/speech therapists, and other certified faculty whose role is focused on direct, in-person services to students.\*
- Designate an assigned starting date and time for the area code of your school district. Projects entered on the DonorsChoose website prior to the district's assigned day will be ineligible for OSDE funding.
- Fund qualified projects on a first-come, first-served basis until the proportional amount for each area code is expended.

**\*to maximize funding for classroom use, virtual teachers, paras, curriculum specialists, coordinators, assistant principals/principals, and other administrative roles are NOT eligible to apply.**

# Key Attributes of the CLASS Grant

- Garnered input from teachers and administrators before and after the initial CLASS Grant.
- Created a second allocation of \$6M in the OSDE portion of ESSER funding for school-approved teacher grants of up to \$800 in supplies and taxes.
- Partnered with DonorsChoose to assist with grant processing, review, ordering, delivery, communication, and federal reporting requirements.

# Keep in mind...

- Teachers Pay Teachers gift cards are not permissible.
- Professional development experiences cannot be purchased.
- Field trips or substitute teacher costs are not allowable.
- **PRIOR** to your submission, the administration in your building (or in your district) must approve your project. By submitting a project, the teacher acknowledges and accepts responsibility to follow district guidelines and state laws.

# CLASS 2.0: Let's do it again!

The \$6 million Classroom Learning and School Supplies (CLASS) grant opens over a three days beginning:

**The CLASS Grant will go LIVE at 4 p.m. on each of these days and remain active until funds are expended.**

# Equitable Allocation Breakdown

- Based on the number of teachers serving students in each area code, the \$6 million has been divided in three equitable amounts to ensure teachers from across the state have ample opportunity to apply.

TEACHERS WHOSE SCHOOL DISTRICT AREA CODE IS **580** WILL APPLY **TUESDAY, NOVEMBER 1** AT 4 P.M.  
USE CAMPAIGN CODE: **OKLAHOMA580**

## AREA CODE 918

TEACHERS WHOSE SCHOOL DISTRICT AREA CODE IS **918** WILL APPLY **WEDNESDAY, NOVEMBER 2** AT 4 P.M.  
USE CAMPAIGN CODE: **OKLAHOMA918**

## AREA CODE 405

TEACHERS WHOSE SCHOOL DISTRICT AREA CODE IS **405** WILL APPLY **THURSDAY, NOVEMBER 3** AT 4 P.M.  
USE CAMPAIGN CODE: **OKLAHOMA405**

Any project that is started or posted on the DonorsChoose website prior to the date assigned to each district, will not be eligible for OSDE federal funding.



# Final Reminders

- **PRIOR** to the teachers' submission, the administration in the building (or in your district) should know and approve each project. By submitting a project, teachers accept responsibility for meeting district guidelines and state laws.
- **ALL** items received become the property of the school district and should be inventoried (except consumables) per federal grant guidelines. (Please consult your federal programs administrator for guidance.)
- **Whitelist** DonorsChoose's URL, if possible. Communication between teacher and DonorsChoose will be much faster and easier.
