Information from the State Superintendent

Superintendent Hofmeister welcomed everyone to the meeting.

Updates were provided on the Oklahoma Supreme Court's Opinion in *Oklahoma's Children, Our Future, Inc. v Coburn,* 2018 OK55, in part deeming the teacher pay in force and effect as of August 1; Teacher Externship Program; 2nd Food 4 Thought summer meal initiative; Troops to Teachers \$1.2 million 5-year grant; and year-to-date emergency certification data.

Recognition of Dyllon Wheeler, 2018 Oklahoma Geography Bee Champion

Superintendent Hofmeister recognized Dyllon Wheeler, an 8th grade student at EPIC Charter school, who won the Oklahoma Geography Bee.

BOARD ADMINISTRATIVE

May 24, 2018 Regular Meeting Minutes of the State Board of Education – Approved

Presentation and discussion relating to school security

Mr. Lou Sims, retired member of the United States Secret Service and White House Security Team, presented the "Making School Safer" guidelines to detect and prevent horrific acts in schools. Mr. Sims provided documents designed for Oklahoma schools to prevent potential school shootings that included instruction for emergency plans, student profile and behavioral indicators, parental/student participation; implementing Threat Assessment Teams, Red Flag/Alerts notifications/reporting, HELP Line notifications/assistance systems; Fire Alarm Activators and relocation, and creating comprehensive prevention plans.

Board members discussed and asked questions on current state school security statues, SBE rules and legislative recommendations; effective security mandates and implementation, law enforcement and community participation; student security and safety presentations at summer conferences.

Superintendent Hofmeister informed the SDE is in pursuit of a federal grant to fund program and training.

Dr. Robyn Miller, Deputy Superintendent, Educator Effectiveness and Policy said if awarded, the Students, Teachers, and Officers Preventing School Violence (STOP) competitive grant from the Bureau of Justice Assistance would allow for behavioral threat assessment training for school teams, community responders, and student teams/reporting.

FY2019 Education Budget – Approved

Carolyn Thompson, Chief of Government Affairs, presented a recommendation request to approve the Fiscal Year 2019 Education Budget that included final FY18 appropriations and increased appropriations for Financial Support of Public Schools, Flexible Benefits Allowance, Support of Public School Activities, and Administrative/Support Functions of the Oklahoma State Department of Education (OSDE) pursuant to Senate Bill 1600-General Appropriations. Common education funding, excluding the Public School Activities Budget, increased by \$464,585,318 and total appropriations totaled \$2,912,985,147.

Ms. Thompson reviewed legislative bills and increases, restored line item funds, salary schedule changes, matching funds, and one-time bonuses for Speech Language Pathologists and Audiologists.

Board members asked questions and discussed the current revenue shortages and National Certified Teacher Bonus.
