State Superintendent Joy Hofmeister called the State Board of Education regular meeting to order at 9:34 a.m. and welcomed everyone to the meeting. Ms. Cheadle called the roll and ascertained there was a quorum.

STATE SUPERINTENDENT

Information from the State Superintendent

Superintendent Hofmeister said 916 emergency certifications requests will be presented to the State Board for the month of August. The 2153 emergency requests for August, July and June reveals the full weight of the teacher shortage crisis warned about for over three years. Updates were provided on the Year 2-Individual Career Academic Planning (ICAP) Pilot Program and community involvement tools.
