Career Development Program for Paraprofessionals to Become a Certified Teacher TEACHER CERTIFICATION SECTION

WHO IS ELIGIBLE?

A teaching assistant with at least one year of experience in a public school

A public school paraprofessional is an employee of a school district whose position is either instructional in nature, or who delivers other direct services to students and/or their parents. A public school paraprofessional serves in a position for which a teacher or another professional has the ultimate responsibility for the design, implementation, and evaluation of the individual educational programs or related services and student performance. 70 O.S. § 159.1

The Oklahoma State Department of Education (OSDE) shall issue a one-year provisional certificate, renewable for up to three years, for early childhood, or elementary education, or special education to a paraprofessional who meets the following requirements:

Bachelor's Degree from an Accredited College (cumulative GPA 2.5 req.)

At Least one year of continuous employment as a paraprofessional in a Public School accredited by the State Board of Education in the Area being pursued.

╋

• Pass the General Education Test (OGET), Oklahoma Professional Teaching Exam (OPTE), and Oklahoma Subject Area Test (OSAT) in Early Childhood Education, or Elementary Education, or Special Education

SAT must be in the area your public school experience was earned.

• Pass the Federal Bureau of Investigation (FBI) criminal history record check

OSDE Issues provisional certificate to be Eligible for Employment (with app & \$30 fee) (Valid for up to 3 Years – Non-renewable)

╋

Within three (3) years, complete twelve (12) semester hours of professional education coursework from a higher education institution accredited by the Oklahoma Commission for Teacher Preparation with an approved program in the certification area held. The twelve (12) semester hours must include a minimum of three (3) semester hours in reading instruction.

After one year of continuous employment in a Public School accredited by the State Board of Education in the area earned, submit 2 favorable recommendations for a standard certificate, one from the district board of education and one from the chair/director of education from the program the 12 hrs. were completed.
