LEAs should be aware that variations in scoring and reporting methods, as well as the norm-referenced nature of the assessments themselves, limit the ability to determine qualifying scores for each assessment across all of its applicable grade levels. As such, some interpretation may be necessary to determine if a score qualifies a student for ELP Band Exit. Generally, a qualifying score must be at or above the 35th percentile in the applicable subtest or composite score, but in cases where the assessment does not report scores in percentile format, this rule may be interpreted as a score within the upper two-thirds of the applicable subtest or composite scoring range.

Additionally, certain assessments listed below are also state-approved RSA screeners. **LEAs should note that the same NRT score may not be submitted to meet the requirements of both Element #2 and Element #5 of the ACCESS for ELLs ELP Band Committee Rubric.** If element #2 is met with a state-approved RSA screener noted in the table below, element #5 must be met with a different approved assessment. **Any NRT used to meet element #5 must be conducted in English for the purpose of ELP Band Exit.**
