
Introduction: The State of Charter Schools in Oklahoma

Since the passing of the Oklahoma Charter Schools Act in 1999, there have been a total of 43 charter schools founded in Oklahoma, 30 of which are still in operation.

In 2015, along with the statewide expansion of charter schools, amendments to the Oklahoma Charter Schools Act (the "Act") also brought a new level of accountability. According to the National Alliance for Public Charter Schools, Oklahoma made the biggest jump in state charter law rankings because of the overhaul of its law, including statewide expansion, school and sponsor accountability, and replication of high-quality charters. Further, upon the overhaul of Oklahoma's charter law, National Association of Charter School Authorizers (NACSA) stated that "Oklahoma now has one of the nation's strongest charter laws ... with a focus on school accountability and strong standards" for sponsors.

Oklahoma law now requires that the State, as well as charter sponsors, provide annual performance reviews of charter schools. In fact, the Act is replete with requirements that work to ensure that charter schools are meeting the terms of the school's charter, academic and/or operational goals and measurable achievement benchmarks. Specifically, the Act grants a sponsor the affirmative power and duty to "provide oversight of the operations of the charter school ... through annual performance reviews of charter schools and reauthorization of charter schools for which it is a sponsor."



Administrative Services Fee Collection 2022-23 School Year


The Act allows sponsors/authorizers to collect a fee for administrative services that must not exceed 3% of the charter school's State Aid allocation. The graph below shows the estimated fees collected by authorizers during the 2022-23 school year and totaled \$4,469,235

State Aid Allocated to Oklahoma Charter Schools



Federal Funds Allocated to Oklahoma Charter Schools



(Total excludes Special Education, Child Nutrition Program funding & any Covid19 related federal funds). The total Federal Funds allocation to charter schools in the 2022-23 school year was \$69,245,796.

Oklahoma Charter School Enrollment


During the 2022-23 school year, there were a total of 705,979 students enrolled in OSDE accredited Oklahoma schools. The breakdown is shown below:

Oklahoma Charter School Enrollment


During the 2022-23 school year, 30 charter schools served 50,716 students, or about 7.2% of the overall student population in Oklahoma public schools. While overall, the number of students served by charter schools has increased dramatically through the years, 22-23 shows a decrease reflected in the Virtual Charter School numbers. This is most likely due to students returning to Resident Brick and Mortar schools following COVID.

Oklahoma Brick-and-Mortar Charter Demographics


Brick-and-mortar and virtual charters have vastly different demographic ratios. These demographics show a large populace of what might be considered a minority population.



Graduation Cohort Data

In 22-23, there were 19 charter high schools, 4 of which had too small a population OR have not been in operation long enough to collect data and 1 juvenile incarceration center. These 5 schools have been excluded from the table below.

Students are assigned a four-year cohort year upon entering high school and remain in the assigned cohort until they graduate, which can extend out to 6 years. This graduation indicator shows the graduation rate for the four-year graduates only.
