Accessing the Wave

- Verify you have an affiliates login to access the Wave
- Verify that login is working
- No login, Superintendent must provide Wave access on SSO
- Enter a ticket with OMES requesting an affiliates login
- servicedesk@omes.ok.gov
- It should take 48-72 hours for access to be provided

 - PK3 – for students under the age of 5
 - Pre-ISP- for all other students

Class Size Audit

- Phase II – 9/15 to 9/30
 - Exclude teachers who are not teaching
 - Exclude classes that are not real classes
 - Assign co-teachers to classes
 - Assign teacher aides to classes
 - Assign detailed class information for populating Accreditation Report

Class Size Audit

- Phase III – 10/1 to 10/16
 - Review and adjust data as needed
 - Confirm and Certify the CSV Report
 - Send the CSV information to Accreditation Report
 - Confirm and Certify the Accreditation Report

- This report is live and due no later than October 31, 2023. No corrections to student data can be made after the due date. The earliest date this report can be certified is October 3, 2023. Certification of this report includes the Special Education Child Count Report. 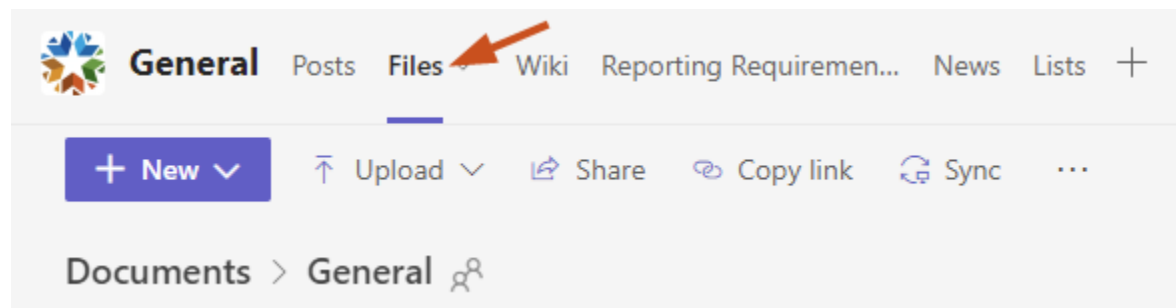
FQSR

Students graduating in 2023

- We are seeing quite a few districts that are reporting students as graduated with a standard diploma in 2023 and the student is still enrolled in this school year.
- In October/November, Accountability will be conducting the cohort graduation report for SY 2023.
- For Accountability purposes, any student currently enrolled in membership will not be counted as a graduate regardless of the 2023 exit code (DVRs may still be submitted if the enrollment is at another district and the graduating district can show they did what they were supposed to do).
