## 2021-2022 School Year

The Oklahoma State Department of Education has reviewed the subject codes available on the Accreditation<sup>1</sup> website for accuracy, consistency, and ease-of-use. A number of changes to the subject codes will go into effect for the 2021-2022 school year in an effort to improve advising and course offerings for all Oklahoma students. Notes about revisions are provided in this document for reference. All changes are either a **Deletion**, **Addition**, **Revision**, or **Move**. Decisions about such changes have been informed by the following five factors:
