Todd Loftin (OSDE): OSDE Updates

Summit on Behavior and Climate in Schools

The Oklahoma State Department of Education – Special Education Services Department will be hosting a Summit on Behavior and Climate in Schools. The Summit consists of a series of activities led by a Guiding Coalition with various of expertise needed to assist in accomplishing the Summit's mission to positively impact the climate and culture of Oklahoma Schools. The Guiding Coalition will be tasked with developing well-informed recommendations for legislative, pre-service and in-service supports designed to address the social emotional and behavioral needs present in Oklahoma Schools. These recommendations will be formed from input gathered through survey responses and regional focus groups led by OSDE staff, and comprised of parents, community members, educators, and students.

Jill Burroughs of Public Consulting Group (PCG) gave a detailed presentation on Parent Connect, a new software system that will allow the student's parent or guardian to virtually access their child's IEP or 504 Plan documents, service information, and teacher of record information.
