Kite User Accounts

Teachers should only be added to the Kite Educator Portal if they currently have a student who will participate in the OAAP in their classroom and the teacher will be administering the alternate assessment in the current school year. Please do not add teachers to Kite to plan ahead. Teachers must complete the Required Test Administrator training prior to having access to information in Kite, and, if a teacher is not administering the assessment in the current school year, it is not necessary for them to complete the training. Once the training has been completed, a teacher will automatically be placed in the Returning Test Administrator Training which is a reduced training meant for teachers who have administered the assessment and are already familiar with the assessment administration.

OAAP IEP Reminders

- All students participating in the alternate assessment need to have cognitive and adaptive behavior assessments completed and uploaded to EdPlan. Please remember these are on [The Criteria Checklist for Assessing Students with Disabilities on Alternate Assessments](#).
- All students participating in the alternate assessment need an adaptive behavior goal on their IEP.
- All goals should have at least two objectives.

District Level OAAP Participation – Justification Survey

If your district is anticipating more than 1.0 percent of your testing population (Grades 3-8, and 11) will participate in the OAAP/DLM testing in the 2024 spring operational window, the survey: [“2024 Justification for Exceeding 1.0 % in OAAP Participation”](#) must be completed online by **March 1, 2024**. If your district is not expecting to exceed the cap, no action is required.

The survey is designed to be completed by someone at the administrative level with special education and state testing knowledge. It may be completed by either the District Testing Coordinator, Special Education Director, or someone in a similar position.
