Instructionally Embedded Assessment

The Instructionally Embedded Assessment window will close on **February 23, 2024**. The Student Progress Reports will be removed from Kite Educator Portal since the Instructionally Embedded Assessments are optional for our state. If your district would like to keep this information, please download all information **by 5:00 p.m. on February 23**rd.

Training Status Report

DTCs can pull the Training Report in Kite Educator Portal to review and remind educators to complete their required training before the start of testing. In Kite Educator Portal select **Reports** and **Data Extracts**. Select the **Data Management** tab. The report that allows you to monitor the training completion is titled, **Training Status**. Spring Testing Window Reminders

- Test Administrator training is located in Kite Educator Portal under the **Training** section. All training must be completed before educators can access the testlets.
- The First Contact Survey and Personal Needs and Preferences Profile (PNP) should be completed by March 20th for testing to begin on March 25th. If educators wait until after the testing window opens, they will have to wait 24 hours after they complete the First Contact Survey and the PNP for the testlets to show up in Kite.
- Please check if the student's STN and grade level are accurate in DLM before the testing window opens on **March 25**th.





• DLM has released a flyer with information regarding <u>Test Administration Timing</u> <u>Considerations</u>. It provides information on what time is considered average for a testlet and what is considered too short according to their data on testlet administration for students with the most significant cognitive disabilities.

District Level OAAP Participation – Justification Survey

If your district is anticipating more than 1.0 percent of your testing population (Grades 3-8, and 11) will participate in the OAAP/DLM testing in the 2024 spring operational window, the survey: "<u>2024 Justification for Exceeding 1.0 % in OAAP Participation</u>" must be completed online by **March 1, 2024**. If your district is not expecting to exceed the cap, no action is required.

The survey is designed to be completed by someone at the administrative level with special education and state testing knowledge. It may be completed by either the District Testing Coordinator, Special Education Director, or someone in a similar position.
