

## RULE IMPACT STATEMENT

### 210:1-1-1. Purpose Declaration of Foundational Values [AMENDED]

### 210:1-1-7. Purpose [NEW]

a. **What is the purpose of the proposed rule change?**

The purpose of this rule is to define the foundational values and principles of public education in the State of Oklahoma for use by the State Department of Education.

b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**

The rule change will impose minor informational costs on the State Department of Education in order to ensure programs and initiatives comply with foundational values and principles.

c. **What classes of persons will benefit from the proposed rule change?**

The rule change will benefit students and school communities by ensuring that the Department operates in line with the values and principles of most Oklahomans.

d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**

The agency anticipates minimal economic impact upon political subdivisions or affected classes because of implementation of the proposed rule change at this time, because the rule primarily sets governing principles for the Department.

The agency anticipates minimal cost to the agency to implement and enforce the rule as a result of the proposed change in the rule at this time. Additional record keeping, if any, will be performed by existing staff.

f. **What is the economic impact on any political subdivision to implement the proposed rule change? Will the rule require their cooperation in implementing or enforcing the rule?**

The agency anticipates minimal economic impact on any political subdivision to implement the proposed rule change at this time because the rule primarily sets governing principles for the Department.

The agency does not anticipate any adverse economic impact on small business as a result of the proposed rule change at this time.
