

RULE IMPACT STATEMENT

210:35-9-31 Additional Standards for Secondary Schools [AMENDED]

a. What is the purpose of the proposed rule change?

The purpose of this rule is to comply with a new statute, 70 O.S. § 1210.508-6, regarding requiring the Free Application for Federal Student Aid (FAFSA) for graduation.

b. What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?

The rule change will impose minor informational costs on local education agencies (LEAs) who serve graduating students and must track compliance and provide information to students.

c. What classes of persons will benefit from the proposed rule change?

The rule change will benefit students and school communities by ensuring that they receive timely and accurate information from their school regarding graduation requirements.

d. What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?

The agency anticipates minimal economic impact upon political subdivisions or affected classes because of implementation of the proposed rule change at this time because the rule merely directs LEAs how to perform certain statutorily required actions.

e. What is the probable cost to the agency to implement and enforce the proposed rule change?

The agency does not anticipate any cost to the agency to implement and enforce as a result of the proposed change in the rule at this time. Additional record keeping, if any, will be performed by existing staff.

f. What is the economic impact on any political subdivision to implement the proposed rule change? Will the rule require their cooperation in implementing or enforcing the rule?

The agency anticipates minimal economic impact on any political subdivision to implement the proposed rule change at this time because the rule merely directs LEAs how to perform certain statutorily required actions.

- g. **Will implementing the rule change have an adverse effect on small business as provided by the Oklahoma Small Business Regulatory Flexibility Act?**

The agency does not anticipate any adverse economic impact on small business as a result of the proposed rule change at this time.

The agency does not anticipate any material costs and is not aware of any measures that would minimize costs as a result. The agency is not aware of any other methods that could achieve the intended goal at a reduced burden.
