Crossover Preparatory Academy (72 P055 505; 72 P055 705) is accredited through the Oklahoma State Department of Education as a Middle School and High School.

What services and support do you offer students with disabilities?

Once approved we will hire a special education teacher. We will also contract with an outside agency to provide kids with speech, occupational, physical, and other therapy needs to meet the requirements of their Individualized Education Program (IEP). We will also provide paraprofessionals for students who require that level of support.

Please list below any additional information you would like the State Board of Education to consider for adding your school to the list of approved private schools for the Lindsey Nicole Henry Scholarship.

In addition to the above services, we will be adding a reading specialist to our staff next year. 100% of our students already have an Academic Coach who monitors their progress and ensures that the requirements of their IEP are being met. The additional services listed above will be on top of the support that all Crossover Preparatory Academy students already receive.

Students who meet the financial requirements of the Oklahoma Equal Opportunity Education Scholarship Act receive a full tuition scholarship from the Crossover Scholarship Fund. Students who do not meet those requirements would pay full tuition. Tuition for the 2019-2020 school year will be \$7500.
