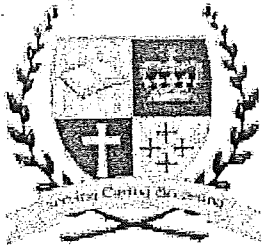

It is the desire of St. Charles Borromeo Catholic School to participate in the Lindsey Nicole Henry Scholarships for Students with Disabilities Program.

St. Charles Borromeo is a fully accredited school through the Oklahoma Catholic Schools Accrediting Association and through reciprocal agreement by the Oklahoma State Department of Education. The school has been in existence since 1954/1955, and currently enrolls around 200 students in Pre-Kindergarten through Grade 8. All homeroom teachers are certified by the State of Oklahoma. As for myself as administrator, I have all the requirements meant for certification; however, I am working toward obtaining the updated documentation. Of the 13 full time teachers and administrators, 11 have at least 3 years of teaching experience.

St. Charles Borromeo currently works with Putnam City Public Schools in providing speech therapy and special education tutoring to qualified students on ISPs. In addition, St. Charles Borromeo employs part-time paraprofessionals as well as a reading teacher to assist with student tutoring, study skills-for-students with special needs, and coordination of efforts.

St. Charles Borromeo adheres to the tenets of Title IX. In addition, St. Charles Borromeo admits students regardless of gender, race, color, physical disability, national and ethnic origin to all rights, privileges, programs, and activities generally accorded or made available to students.


The school currently has a \$850,000 dollar operating budget. The school's finance are managed together with the St. Charles Borromeo Catholic Church. The person who does this also assists in the finances of a few other Catholic schools within the Archdiocese.

In addition, St. Charles Borromeo works with the county health department and the Warr Acres Fire Department to ensure that the school meets health and safety codes. St. Charles Borromeo maintains an updated Crisis Management Handbook, and practices fire, tornado, evacuation and lock-down procedures throughout the school year. In addition, St. Charles Borromeo works towards and follows a school-wide disciplinary code.
