## CALL TO ORDER <br> ROLL CALL

State Superintendent Ryan Walters called the State Board of Education regular meeting to order at 9:36 a.m. Ms. Terrie Cheadle called the roll and ascertained there was a quorum.

## PLEDGE OF ALLEGIANCE, OKLAHOMA FLAG SALUTE, AND MOMENT OF SILENCE

Superintendent Walters welcomed everyone to the meeting and led Board Members and all present in the Pledge of Allegiance to the American Flag, a salute to the Oklahoma Flag, and Prayer.

## STATE SUPERINTENDENT

## Information from the State Superintendent

Superintendent Walters thanked board members and gave comments and updated on the Chinese Party influence in public schools and Chinese Government funding investigations; Congressional testimony on Oklahoma's national interest; Chinese Communist Party contracts within Tulsa Public School District, lack of transparency and parent notification; recommendations to Congress no indoctrination and undermining by foreign powers, make foreign power funding unlawful and foreign data sharing illegal; State Board of Education commended for swift action and request Oklahoma legislature act upon recommendations.

Updates included the "Back to Basics" academic plan focusing on reading math, science, and civics; $\$ 8$ million initiatives/programs to improve student outcomes, FY25 budget focus includes tutoring plan, accreditation process changes; and judicial decisions requiring birth certificate gender changes.

## FY 2024-25 Education Budget - Approved

FY2025 Education Budget overview included the State Department of Education Vision to empower parents, kids, and all Oklahomans with the best education system for the future, and Goals to eliminate indoctrination and re-focusing on reading, science, math, and civics; recruit and reward teachers, increase school choice options, create education system transparency and efficiency; and recommend a $\$ 3,922,000,000$ budget request.

Board members reviewed the FY25 and FY24 appropriations comparisons, funding formula levels, budget request change summary, increase and decreases, new Back to Basics plan investments and free management principles; questions and discussions included pilot program, trainings, teacher compensations, bonus, credentialing performance improvement grants and request legislative funding for program expansion.

Board member Reynolds moved to approve the FY2025 budget request. Board member Quebedeaux seconded the motion. The motion carried with the following votes: Mr. Burdick, yes; Ms. Lepak, yes; Ms. Quebedeaux, yes; Ms. Wesson, yes; and Superintendent Walters, yes.

## Proposed 2024 School Capital Improvements Budget - Approved

Mr. Cleveland advised a School Capital Improvement report for school districts is mandated by legislation but in past years none were filed by the State Board of Education. No districts are requesting funds at this time, and instead of ignoring the report it is more appropriate to present and file a letter of explanation as to why this is not done.

Board members asked questions and discussed if the number is zero all districts are exempt from submitting report, and formal response compliance to state statute.

Board member Burdick moved to approve the request to submit the School Capital Improvement Budget report. Board member Quebedeaux seconded the motion. ## ACCREDITATION STANDARDS DIVISION

## Presentation from Tulsa Public School District, discussion, and possible action on the Tulsa Public School District accreditation status for the 2022-2023 school year

Representatives of Tulsa Public School District (TPS) attending the meeting included Dr. Ebony Johnson-Interim Superintendent, Stacey Wooley-Board President, Dr. Jeanettie Marshall-Board member, Jorge Robles-Chief Finance and Operations Officer, and Paula Shannon-Deputy Superintendent.

Dr. Johnson said she appreciated the opportunity to present before the Board on her ninth day as Interim Superintendent of Tulsa Public Schools and wanted the board to know she will be responsive, results-oriented and is completely and utterly dedicated to the work. She has embraced intensive hard work as a school administrator and as Chief Academic Officer used data to drive instruction and ensured teachers had quality curriculum, materials, and professional learning. Dr Johnson and TPS team thanked State Board members Burdick and Wesson for their engagement and commitment. The TPS team understands it is critically important to use the data to drive the change we want and are resilient to ensure the narrative of TPS is truly realized to move forward, overcome and be great for our schools and community and we will. Dr. Johnson said the TPS team are mindful of the day-to-day challenges schools face to move our students; consistent data will provide the trends that we are moving in the right direction; and said the presentation includes the science of reading, F school corrective action plans, internal controls, and updates regarding progress.

Ms. Wooley said quarterly strategic plan meetings are conducted to review the data on each goal and will determine if we are trending in the right direction. There is accountability and adult behavior changes, transparency and the superintendent evaluations are based on student outcomes. We are going in the right direction.

Board members were provided notebook documents to review how TPS addresses science of reading, provides professional development, data team meetings and expectations, and budgetary internal controls; and discussed and asked questions on the goals, guardrails and strategies of the Pathways to Opportunity 2022-2027 Strategic Plan; preliminary budget preview (2022-23, 2023-24) 2023-24 School Budget and Financing Plan-Executive Summary and update on TPS District team member and student demographics; literacy and science of reading, corrective action plans and new internal controls, timeline projection on goals, test scores and growth, pre-pandemic outcomes and pandemic impact; and highlighted 2023 National Blue Ribbon High School-Booker T. Washington, TPS a charter school authorizer, charter schools (pre-K-12 and college-bound) and magnet schools (EM, MS and Academic); finance support committee, expenditure processes/safeguards; Amira Learning (artificial intelligence program); CSI and MRI school collaborations; thank you to State Board members Burdick and Wesson engagement and commitment.

## FINANCE

> Provided one-time FY2024 Severance Allowance Payment to former Employees of Terral Public School District, which were not employed or paid severance by the receiving district. Annexations took place in FY2023 - Approved

Renee McWaters, Program Manager, Office of State Aid, said Terral Public Schools annexed to Ryal Public Schools on June 30, 2023, and presented a request to provide severance payments to thirteen (13) employees of the annexed district who applied for employment but denied employment by the receiving district. State law allows the employees to apply to the State Board of Education to use approximately $\$ 230,014$ severance payment from the School Consolidation Assistance Fund.

Board member Burdick moved to approve the request to pay Terral Public School employees out of the School Consolidation Assistance Fund. Board member Reynolds seconded the motion. ## SCHOOL \& DISTRICT SUPPORTS

## Comprehensive Support \& Improvement (CSI) and More Rigorous Intervention (CSI-MRI) designations for school sites

Superintendent Walters presented failing schools designated as Comprehensive Support \& Improvement and More Rigorous Intervention (MRI) designations or CSI-MRI schools (42) earning an F on the Oklahoma School Report Card three consecutive years. The schools continue to fail with rigorous intervention, additional funding, support, and resources. Superintendent Walters and board members reviewed average proficiency rates, district MRI schools, current MRI procedures, support, improvement plans implemented, technical assistance provided; Oklahoma ESSA plan does not address MRI sites; metric needed to ensure schools maintain academic results pursuant 70. O.S. §3-104.4 Standards for Accreditation of Public Schools; board member feedback and recommendations needed to change and develop best practices to improve accreditation standards.
