- Upcoming change in the Oklahoma State Department of Education (OSDE) Single Sign On (SSO) password and account policy, which is being implemented in accordance with the Oklahoma State Information Security Policy and Password Requirements Standard.
- Effective November 1st, 2023, the SSO passwords for all account holders will be set to expire every 90 days. We're introducing this policy as part of our unwavering commitment to protect the confidential data belonging to students, educators, and staff members. This measure is also designed to enhance the security of our systems and to further secure the sensitive information we manage.






Figure 3. Reset Password Page
