New Single Sign-On Password and Account Policy Implementation

- Upcoming change in the Oklahoma State Department of Education (OSDE) Single Sign On (SSO) password and account policy, which is being implemented in accordance with the Oklahoma State Information Security Policy and Password Requirements Standard.
- Effective November 1st, 2023, the SSO passwords for all account holders will be set to expire every 90 days. We're introducing this policy as part of our unwavering commitment to protecting the confidential data belonging to students, educators, and staff members. This measure is also designed to enhance the security of our systems and to further secure the sensitive information we manage.

New Single Sign-On Password and Account Policy Implementation

- Be proactive and don't get caught at a time you need quick access to SSO.
- Any password older than 90 days will expire and must be reset on Nov 1st.
- This does not affect Wave affiliates accounts, but you will need to sign in to SSO before you can sign into your affiliates account.

STN (State Testing Number) Tool

- Access through SSO
- If an STN is missing check Data Validation and pending resolutions
- District's responsibility to resolve any pending resolutions
- Resolve outstanding STNs located in the Single Sign On
- Students in the queue could not be automatically resolved
- Students without an STN will not show on reports
- If assistance use the contact OSDE button

Ownership Wizard

- Access through SSO
- Verify the district
- Select student or district view
- Expand the + to view the conflict
- Determine why conflict exists
- Expand the + to view the contacts of the other district
- Contact the district to resolve issue
- If the conflict is with your district, contact OSDE

Data Validations

- Access the Wave through SSO
- Select District >Data Validation>Data Validation Wizard
- Errors displayed by site
- Option to view by student or error
- View the error explanation
- View the SIF XML
- Send the explanation and XML file to your vendor
- Errors impact state reports, STN assignment, EdPlan
- Warnings impact course codes, lunch eligibility, language codes

Accountability Reporting

- 2024 Data will be visible within 2 weeks
- Look at your coursework for 2023
- If not correct we may be able to use student academic record, only if you sent 2 grades
- DVRs for dropout and graduation enrollments will be available soon.
- Students on the dropout list have not enrolled in another Oklahoma school. DVRs will allow corrections for out-of-state or private school enrollments.

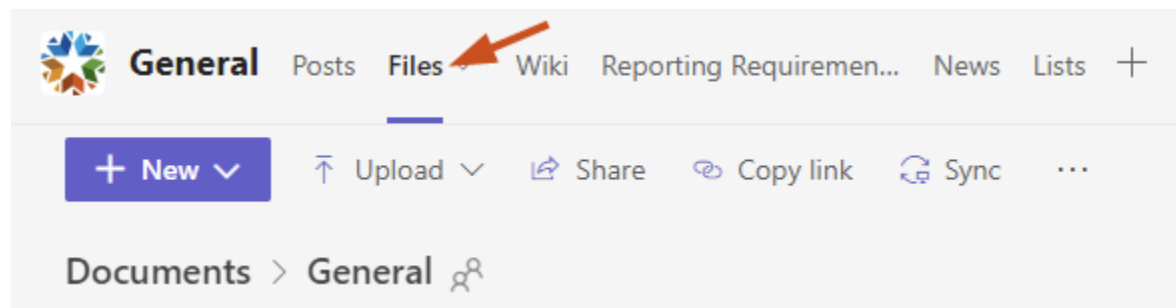
