## Affiliates Login for the Wave

- Verify you have an affiliates login to access the Wave
- Verify that login is working
- If no login exists Superintendent must give you Wave access on SSO
- Enter a ticket with OMES requesting an affiliates login
- It should take 48-72 hours to access to be provided

### Medicaid Wave Warning

- Districts need to confirm they are sending the correct value
- If you have an approved app for "Free" it is ok to be in conflict with Direct Cert
- A warning means to check and see if what is showing in the Wave is what you expect to see
- Warnings do not prevent data from going to state reports
- Errors must be corrected as they will block students from state reports

- Resolve all pending STN resolutions (STN Tool- SSO)
- Resolve all ownership conflicts (Ownership Wizard- SSO)
- Correct all errors in Data Validation (Data Validation-Wave)
- Check your Calendars- Accountability Reporting and FQSR

## State Reports October 1 Consolidated

- October 1<sup>st</sup> Consolidate Report Opens 9/1/2023 for review
  - Confirming and Certifying of sites will begin Oct 3, 2023
  - Check Find Missing Students
  - Remember Certifying this report will also certify your Child Count.
  - Child count appeal window will be from October 2, 2023, to October 16, 2023
  - Closes 10/31/2023
- Due Dates are not a suggestion, they are a deadline.


