# **Accountability Reporting**

Meets to approve or deny requests for absences to be medically exempt based on <u>OAC 210:10-13-25.</u> , local board policy, and supporting documentation. Sample <u>Board Policy</u> Sample <u>Documentation</u>	Uses the CA Medical Exemption Window process to submit requests and upload the committee's approved absences and documentation for each student.	Reviews requests and supporting documentation for each student's medically exempted absences to approve or deny request. <b>Note:</b> Admin User must be different from the Site User

# Demographic Overlay Window- Now Open

- Schools should review demographic information for students participating in the Oklahoma School Testing Program(OSTP).
- Snapshots of the demographic information in the Accountability Reporting application will be taken on the dates below.
- This data will be used in future reports. Because of this, it is vital to ensure that the Accountability Reporting application is accurate. Guidance on the Demographic Overlay window can be found at: <u>https://sde.ok.gov/sites/default/files/Demographic%20Overaly%202023.pdf</u>
- April 20, 2023 High School and Grade 3 Early RSA
- May 10, 2023 Grades 3-8



## **Annual Statistical Review (ASR)**

- Opened on 03/01/2023 Closes on 6/30/2023
- Clear Ownership conflicts and data validation errors.
- Check calendars and make sure you are meeting your school day requirement of 165 total days to include 158 days of instruction, 2 PT, and 5 professional days minimum.
- Enter your graduate exit codes and exit dates before certifying your ASR.
- Contact State Aid (405)521-3460.



#### Alt Ed

- You should be able to view the Alt Ed data on the ASR no later than May 1<sup>st</sup>.
- We have been piloting the ability to utilize Student Participation to also capture the students Alt Ed enrollments.
- This will give districts an option on how they would like to report their data.
- If you are currently a Wen-Gage district you could utilize the Student Participation fields. You will just need to ensure you are providing a start and end date to each Alt Ed enrollment.



#### Alt Ed

- If your district is an Infinite Campus district, there will be and update on April 10<sup>th</sup> that will allow you to use the Student Participation field as well.
- If your district is a PowerSchool district you will also have to take an update for this functionality to work but I have no timeline on their update at this point.
- We are currently working with the other vendors to provide the districts the ability to capture this information through Student Participation as well. No timeline at this point.





- Our system will look at Alt Ed first and if nothing is there it will look to student enrollment.
- Note: If our pilot is successful we will just be utilizing Student Participation for next 23/24.



## **Changing SIS Vendors**

#### Timelines

- March 13-April 15 (4 weeks)
  - Parent online submission form for PEBT issues.
- March 20-April 28 (6 weeks)
  - DVR window open for districts.
- End of May
  - Final SY2022 and Summer file to DHS.



- Communications have been sent to qualifying districts for them to communicate to parents about the parent online form. The form can be accessed at <u>https://sde.ok.gov/pebt</u>.
- OSDE has provided a template that each district can use to message the parents. It will be very important to communicate this quickly as our timeline is very short. You can do this by email or posting a message to your website.
- Parents will only have a 4-week period to make submissions.



- OSDE will send a weekly spreadsheet to the districts.
- The spreadsheet will only contain parent requests for each week.
- Districts can begin validating site-wide calendar distance learning/virtual days and creating DVRs for those starting on March 20<sup>th</sup>.
- Districts can also validate virtual and blended students and create DVRs if needed to correct the basis of admission code of RVON or RVOFF. This may resolve some of the parent's requests proactively.



- OSDE has provided district guidance to assist with the different DVR types that should be created for each circumstance.
- Parents are required to provide the student's 10-digit STN and will be directed to the district for this information.



## **P-EBT SY2022 Qualifiers**

- How does a district qualify for P-EBT SY 2022?
  - The district must have 5 consecutive site-wide distance learning or virtual days due to COVID in SY 2022 or your district must have 5 consecutive days of declining attendance due to COVID in SY 2022.



### P-EBT Summer 2023

- Student must have an approved meal application for F/R status no later than May 26, 2023.
- NO applications will be accepted beyond that date, no exceptions.



#### **Transfers**

- Incoming open transfer results for Q3 and district capacity for Q4 reporting will open on March 17<sup>th</sup> and close on April 17<sup>th</sup>.
- Approved transfer extension may be acted upon May 1<sup>st</sup> through May 31<sup>st</sup>.
- Applications for the 23/24 school year will not be made available until June 1, 2023. You will not be able to approve those requests until July 1, 2023.
