

**RULE IMPACT STATEMENT
TITLE 210. STATE DEPARTMENT OF EDUCATION**

**CHAPTER 1. STATE BOARD OF EDUCATION
SUBCHAPTER 3. DEPARTMENTAL PRECEPTS**

- a. **What is the purpose of the proposed rule change?**
The proposed new rule at 210:1-3-8.1 establishes requirements for establishment of an inventory or index of data elements collected by the State Department of Education through its student data system, and sets forth the procedure for the State Department of Education to add new data elements to the system. The proposed rule also requires the SDE to establish a procedure for response to requests for disclosure and/or transfer of student data deemed confidential that complies with the provisions of FERPA and requires pre-approval of the State Board of Education. The proposed change to the rule is necessary to implement the provisions of the Student Data Accessibility, Transparency and Accountability Act at 70 O.S. 3-168, which was enacted in 2013.
- b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**
The proposed changes will affect public school students and their parents/legal guardians.
- c. **What classes of persons will benefit from the proposed rule change?**
The proposed changes will benefit public school students and their parents/legal guardians.
- d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**
The agency does not anticipate any economic impact upon affected classes of persons or political subdivisions as a result of implementation of the proposed rule change at this time.
- e. **What is the probable cost to the agency to implement and enforce the proposed rule change?**
