Commenter suggests amending the current language in 777:10-3-3(b)(1)(C) to read: "That each statewide virtual charter school has consistent procedures in place governing <b>admission, child find responsibilities, and</b> the evaluation, <b>re-evaluation</b> , and identification of students with disabilities, as well as applicable procedural safeguards, and policies and procedures to ensure provision of <b>free</b> appropriate online and other <b>educational and related</b> services, <b>supplementary aids and services, modifications, accommodations, supports for personnel</b> , and <b>other</b> technical <b>supports provided</b> in the least restrictive environment to students with disabilities and/or other special needs <b>in compliance with applicable federal and state laws and regulations</b> by each virtual charter school provider, including	<ul style="list-style-type: none"> <li>The agency has implemented the proposed change.</li> </ul>
Commenter suggests adding the words "or may require" between the words "require" and "accommodations" in 777-10-3-3(B)(1)(C)(ii) and adding language to this	<ul style="list-style-type: none"> <li>The agency has implemented the proposed change.</li> </ul>

section addressing the breadth of special education and other services available under Section 504 in addition to accommodations. Commenter also suggests adding the words "and Title II of the Americans with Disabilities Act" after "1973."	
Commenter suggests changing the word "of" to "that" in 777:10-3-3(b)(4) so that the line reads "In the event <del>of</del> <b>that</b> a change in contact information occurs during the application process, the Board shall provide the Secretary of the Board with updated contact information."	<ul style="list-style-type: none"> <li>• The agency has implemented the proposed change.</li> </ul>
Commenter suggests deleting the "of" that falls between the words "date" and "the notice" in 777:10-3-3(f)(2)(B) so that the sentence reads " which shall be held no earlier than forty-five (45) calendar days from the date <del>of</del> the notice of intent to terminate is mailed to the charter school; and..."	<ul style="list-style-type: none"> <li>• The agency has implemented the proposed change.</li> </ul>
