CALL TO ORDER AND ROLL CALL

State Superintendent Joy Hofmeister called the State Board of Education regular meeting to order at 1:05 p.m. and welcomed everyone to the meeting. Ms. Cheadle called the roll and ascertained there was a quorum.

PLEDGE OF ALLEGIANCE, OKLAHOMA FLAG SALUTE, AND MOMENT OF SILENCE

Superintendent Hofmeister led Board Members and all present in the Pledge of Allegiance to the American Flag, a salute to the Oklahoma Flag, and a moment of silence.

STATE SUPERINTENDENT

Information from the State Superintendent

Superintendent Hofmeister said Governor Fallin signed the approval of the \$51 million supplemental to Common Education on Wednesday. We are grateful for the Resolutions passed by the Senate and House, Legislators leadership, and the Governor's proposal to provide funds to school districts during these difficult budget/economic times.

The EngageOK Summer Conference is canceled for this year due to budget concerns. However, our plan is to take the conference on the road in order to provide the needed opportunities. Conference teams will bring information to regional sites which will allow participants to attend closer to their areas.

Approximately 1,964 Oklahoma educators collaborated on the Academic Standards with the Standards Steering Committee and State Department of Education (SDE). The work of the committee is nearing the completion of the standards, and as of yesterday the legislative deadline was questioned as to whether the standards were in effect today or Monday. Once the greenlight is given our Oklahoma standards are ready to go.

Legislative Update

Carolyn Thompson, Director, Government Affairs, presented updates on 2016 legislative bills statistics/deadlines/requests that included a review of House and Senate bills on teacher shortage, Teacher and Leader Effectiveness Evaluation System (TLE), Red Tape Task Force, curriculum, testing, and supplemental appropriations.

Board members asked questions regarding teacher pay and school district deregulations/exceptions.

Amend the adjusted Fiscal Year 2016 Budget as a result of the supplemental appropriation received - Approved

Ms. Thompson presented a request to amend the adjusted fiscal year 2016 budget which was the result of the Senate Bill 1572 appropriating \$51 million to Common Education On Wednesday, November 23, Governor Fallin signed the bill for the SBE to allocate funds to the Flexible Benefit Allowance-\$16,640,942.60 million and the Financial Support of Public Schools-\$34, 359,057.40.

Board member Flanagan moved to approve the allocation of \$ 16,640,942.60 to the flexible benefit account and \$34,359,057.40 to the Financial Support of Schools. Board member Ross seconded the motion. Full state intervention of Grant-Goodland Dependent School District

David Kinney, General Counsel, presented a recommendation request to provide oversight and supervision to implement six corrective actions in the Grant-Goodland School District for the remainder of the 2015-2016 school year and through the 2016-2017 school year Mr. Kinney reviewed the corrective action plan including a requirement that the school board provide the State Board of Education with a plan of corrective action by May 1, 2016.

Board members asked questions and discussed district corrective action and how it might affect state aid/students.

Board member Flanagan moved to adopt the SDE plan for Grant-Goodland through the end of the 2016-2017 school year.

Mr. Kinney said the intervention plan starts today through the end of the 2016-2017 school year or July 1, 2017.
