CHARTER SCHOOL TRAINING ACCREDITATION

WHAT IS ACCREDITATION?

- ◉ Comes from OK School Law, OAC, Accreditation Standards
- ◉ Are you doing what you are supposed to be doing - Compliance
- ◉ Accredited Schools are meeting State Requirements
- ◉ State Aid is paid ONLY to Accredited Schools

CHARTER SCHOOL TRAINING ACCREDITATION

Examples of Compliance

- Reports
- Plans
- Policies
- Safety
- Health
- Insurance

CHARTER SCHOOL TRAINING ACCREDITATION

- ⦿ A deficiency indicates the school is not in compliance with a requirement
- ⦿ Accreditation Status - Annual:
 - no deficiencies
 - with deficiencies
 - warning
 - probation
 - accreditation not recommended

CHARTER SCHOOL TRAINING ACCREDITATION

- ◉ Each district has a Regional Accreditation Officer (RAO) that monitors compliance with Oklahoma statutes and State Board rules
- ◉ 12 RAOs cover the state's districts, charter schools, private schools, career techs, and job corps
- ◉ RAOs are a valuable resource

CHARTER SCHOOL TRAINING ACCREDITATION

RAOs conduct periodic reviews and audits to determine compliance

- ◉ Audit Employee Flexible Benefits (Oct, Jan)
- ◉ Audit Attendance/Membership (Nov, June)
- ◉ Accreditation Visit (Feb-May)
- ◉ Summer School (July)
