- S Emergency Transfer notifications: Check several times a week in the Wave Student Transfer System online for transfer applications pending the resident sending district to either approve or deny; **Accreditation/Transfers** (405) 521-3333. [70 O.S. § 8-103]
- F Claims for reimbursement for lunches, breakfasts, snacks, and/or milk (Special Milk Program) served during previous month are due the 10th of each month; **Child Nutrition Programs** (405) 521-3327. [7 CFR, Part 210.8 (b)]

- S Applications, fees, letters from superintendents, affidavits, and supporting documentation for teacher certification exceptions must be filed for submission to the State Board of Education's monthly meeting; **Teacher Certification** (405) 521-3337. [70 O.S. § 6-187]
- F Verify all school bus drivers have taken a pre-employment drug test; **Transportation** (405) 521-3472 [49 CFR Part 382.303]
- F Verify all current school bus drivers are enrolled in a random drug and alcohol testing program that complies with federal standards; **Transportation** (405) 521-3472 [49 CFR Part 382.303]
- S Check for each school bus driver's expiration month/year on their Commercial Driver License/CDL; **Transportation** (405) 521-3472. [OAC 210:30-5-8]

- S Fire Drills: One each semester, first must be within first 15 days and second drill to be after first 30 days, must be documented; **Accreditation** (405) 521-3333. [70 O.S. § 5-148]
- S Intruder Drills: Two minimum, one within first 15 days of each semester; must be documented; **Accreditation** (405) 521-3333. [70 O.S. § 5-149]
- S Lockdown Drills: One each semester, two per year minimum, all employees and students participate at each site; must document; **Accreditation** (405) 521-3333 [70 O.S. § 5-149]
- S Tornado Drills: Two minimum per school year; must be documented; **Accreditation** (405) 521-3333. [63 O.S. § 681; OAC 210:35-3-186]
- S School Bus Emergency Evacuation Drills: Each semester, all students who will be transported in a school bus, either for daily routes or activity purposes, must participate in a bus evacuation safety drill and also receive bus passenger safety instructions; each drill must be documented; **Transportation** (405) 521-3472 [OAC 210:30-5-5]
- S First-time Oklahoma superintendents must enroll in free training offered by the SDE to meet the required 66 hours of superintendent training within their first year; to enroll contact SDE **Accreditation** (405) 521-3335. [OAC 210:20-21-1]
- S Applications for a Statutory Waiver/Deregulation for the span of entire school year, must be received by October 15; **Accreditation** (405) 521-3335. [70 O.S. § 3-126].
