Dear Superintendent:

Under the *Every Student Succeeds Act* (ESSA), districts are required to annually contact officials from all nonpublic schools **within the district attendance area**.

If, after consultation, the nonpublic school wishes for their students, teachers, and other educational staff to participate, the following forms must be completed for each **participating** nonpublic school and submitted to the Office of Federal Programs:

- *District Affirmation of Consultation with Nonpublic School Officials* (page 4)
- *Nonpublic School Low-Income Student Count for Title I, Part A Services* (page 5)

If, after consultation, the nonpublic school does not wish for their students, teachers, and other educational staff to participate, the following forms must be completed for each **non-participating** nonpublic school and submitted to the Office of Federal Programs:

- *Declaration of Intent to Participate in Federal Programs for Nonpublic Schools* (page 3)
- *District Affirmation of Consultation with Nonpublic School Officials* (page 4)

The district is responsible for implementing equitable services for nonpublic school students, teachers, and other educational staff eligible to participate in federal programs. After consultation with each nonpublic school, please submit the completed documents **electronically** to the Office of Federal Programs to EquitableServicesPac@sde.ok.gov no later than **Monday, February 4, 2019**.

If no nonpublic schools exist in the district, and the district has no resident students attending nonpublic schools in another district, complete the certification form below and submit only this page (page 2), electronically to EquitableServicesPac@sde.ok.gov no later than **Monday, February 4, 2019.**
