**SUBJECT:** FY 2021 Shared Superintendent Salary Assistance Application

Attached is a report listing the Shared Superintendent Salary Assistance application submitted pursuant to 70 O.S. § 7-203 for the State Board to review. The Calvin Public School and Moss Public School have entered into mutual contracts with a superintendent and are requesting fifty percent (50%) assistance of the salary or wages for not more than three (3) consecutive years or no more than one hundred fifty thousand dollars (\$150,000). Moss Public School has already received the one-time benefit for a prior application in FY 2015 through FY 2017 and are not eligible per statutory requirements.

The funding for the eligible Calvin Public District of the qualified application will be from the School Consolidation Assistance Fund, paid in four (4) quarterly installments.

Title 70 O.S. §7-203(B)(2):

2. Assistance to school districts which have entered into a mutual contract with a superintendent as authorized pursuant to Section 5-106A of this title in paying the salary or wages of the superintendent. The assistance shall equal not more than fifty percent (50%) of the salary or wages of the superintendent for not more than three (3) consecutive years. In no case shall the total amount of assistance paid over the three-year period be more than One Hundred Fifty Thousand Dollars (\$150,000.00) nor shall any school district be eligible to receive assistance pursuant to this paragraph for more than one three-year time period.
