As a professional teacher leader, she has helped students attain scholastic achievement through direct student-led instruction founded upon standards-based content. Her passion for equitable education manifests in her dissertation, which is focused on the topic of culturally relevant curricula and instruction.

Ofodile earned a BA in Communication and Media Studies from the University of Pittsburgh, an MSA in Educational Leadership and Administration from Trinity University-Washington, and a Doctorate of Education from Howard University in Education Policy.
