Re: Champions of Excellence Grant: Invitation to Apply to Improve Safe and Healthy Conditions

The Oklahoma State Department of Education (OSDE) believes all students should be provided equitable access to a school fostering safe, healthy, and supportive environments that lead students to reach their full potential.

The Opportunity:

The new Oklahoma Champions of Excellence Program provides \$1,200,000 of competitive grant funding for the 2018-2019 school year to create a safe and healthy atmosphere for all students through development and implementation of programs and activities both in school and across the community.

Districts can use these funds to develop, implement, and evaluate comprehensive programs and activities that -

- 1. are coordinated with other school and community-based services;
- 2. foster safe, healthy, supportive, and drug-free environments that support student academic achievement;
- 3. promote the involvement of parents in the activity or program;
- 4. may be conducted in partnership with an institution of higher education, business, nonprofit organization, community-based organization, or other public or private entity with a demonstrated record of success in implementing activities described in this section; and
- 5. may include programs and activities such as
 - a. drug and violence prevention activities and programs;
 - b. school-based mental health services;
 - safe and healthy practices in school or athletic programs (healthy lifestyle, bullying/ harassment prevention, mentoring for at-risk students, dropout prevention programs);
 - d. high-quality training and support related to suicide prevention, crisis management, human trafficking, violence prevention, drug

abuse prevention, and bullying/harassment prevention;

- e. child sexual abuse awareness and prevention;
- f. reducing exclusionary disciplinary practices;
- g. implementing school-wide positive behavioral interventions and supports;
- h. designating a site resource coordinator; and
- i. paying for success initiatives aligned with the purpose of this section.

Invitation to Apply:

The Oklahoma Champions of Excellence Grant prioritizes funding for schools identified as Persistently Dangerous (representing 10 competitive priority points). However, Oklahoma has never had a school designated as such. Still, we know there is much to be done to ensure every child has an opportunity to flourish.

Too many Oklahoma students have no safe haven from challenging, abusive, and harmful environments. Oklahoma ranks 11th in youth with alcohol dependence and illicit drug use. According to Mental Health America (MHA),

Oklahoma is listed at #45 in Youth Rankings. These rankings indicate that youth have a higher prevalence of mental illness and lower rates of access to care. From 2011-2015, Oklahoma ranked 10th highest in the nation for youth suicide rates.

To combat these disheartening statistics, the OSDE has identified the following counties where the violent crime rate is above 2%. If your school district located in part or in whole in one of these counties, your application will receive five competitive priority points.
