FINANCIAL SERVICES

FY16 State Board of Education budget to address the Office of Management Enterprise Services (OMES) declaration of general revenue failure, affecting allocations from January 1-June 30, 2016 Approved

Matt Holder, Chief Operations Officer and Carolyn Thompson Director, Government Affairs, presented a request to comply with a mandatory three (3) percent-\$46.7 million budget cut on the state's December 23 declaration of the general revenue fund failure. All state agencies are required to submit a revised fiscal year 2016 budget today to OMES for budget reductions. The reduced general revenue allocation, adjusted appropriations, reductions and percentages were reviewed.

Board members asked questions and discussed the adjusted budget proposal for FY16, additional revenue failures and formula cuts; and effect on school districts.

Board member Baxter moved to approve the \$46.7 million adjusted FY16 budget request. Board member Flanagan seconded the motion. The motion carried with the following votes: Mr. Price, yes; Mr. Flanagan, yes; Ms. Franks, yes; General Baxter, yes; and Superintendent Hofmeister, yes.
