SUBJECT: Statutory Waiver Concerning Cooperative Agreements for Alternative Education

The following schools are requesting a statutory waiver of 70 O.S. 1210.568, which requires them to enter into a cooperative agreement with another school district if enrollment in their alternative education program is less than ten (10) students for the 2024-2025 school year. Approval is recommended.


- 2. For the second year of operation, Seven Hundred Fifty Dollars (\$750.00) per student; and
- 3. For the third year of operation and each year thereafter, Seven Hundred Dollars (\$700.00) per student.

Statewide alternative education funding shall not be used to supplant existing school district resources or to support programs that do not meet all the criteria for the statewide alternative education system. No alternative education program shall receive less than a total of Ten Thousand Dollars (\$10,000.00) per school year.

- E. By September 15 of each school year, all statewide alternative education funds received and expended for students participating in an alternative education program shall be reported to the State Department of Education by major object codes and by program classifications pursuant to the Oklahoma Cost Accounting System as adopted by the State Board of Education pursuant to Section 5-135 of this title.
- F. Elementary school districts, as defined in Section 5-103 of this title, may request a waiver from the State Board of Education from the requirements of this section to implement and provide an alternative education program. Any elementary school district that has not received funding pursuant to the provisions of subsection D of this section shall be automatically granted a waiver. If a school district is granted a waiver, no statewide alternative education funding shall be allocated to the district.
- G. 1. The State Board of Education shall contract for technical assistance for operation of an Alternative Education Technical Assistance Center. The technical assistance provider shall be an entity located in Oklahoma that has been officially recognized by the United States Department of Education to assess and facilitate dissemination of validated educational programs in Oklahoma. The technical assistance provider shall have priority, if its operations are deemed satisfactory by the State Board of Education and if funds are available, for annual renewal of the contract.
 - 2. The duties of the technical assistance provider shall include, but shall not be limited to:
 - a. providing initial and ongoing training of personnel who will educate at-risk populations through alternative education programs,
 - b. providing technical assistance to school districts to enhance the probability of success of their alternative education programs,
 - c. evaluating state-funded alternative education programs,
 - d. reporting to the State Board of Education the evaluation results of state-funded alternative education programs, and
 - e. providing in-depth program analysis and evaluation of state-funded alternative education programs.
 - 3. The State Board of Education shall not provide funding to an alternative education program that does not receive a recommendation for continued funding in the evaluation provided for in this subsection. Provided, any school district not receiving such a recommendation for continued funding may request a hearing before the Board with a review of the evaluation prior to the Board's final determination.
- H. All alternative education programs shall be subject to statutes and rules applicable to alternative education, including any exemptions from statutory or regulatory requirements authorized by statutes or rule.
- I. An alternative education program may be offered by an individual school district or may be offered jointly by school districts that have formed interlocal cooperative agreements pursuant to Section 5-117b of this title. Any school district submitting a plan for an alternative education program serving fewer than ten students shall enter into a cooperative agreement with another school district to jointly provide the program unless the program has been granted a waiver from this requirement by the State Board of Education.

- J. Any materials or equipment purchased by a school district with revenue received for students participating in an alternative education program shall be used only in or directly for the alternative education program offered by the district or any subsequent alternative education program offered to students enrolled in that district. Such materials and equipment shall be made available exclusively to alternative education students during the hours that the alternative education program is operating; provided, the material or equipment may be used for other purposes when the alternative education program is not operating.
- K. Upon implementation of this subsection as provided for in subsection M of this section and contingent upon the provision of appropriated funds designated for such purpose, all school districts in the state providing alternative education programs as required in subsection B of this section shall expand the programs to include middle-school-grade students. The program shall conform to the requirements of subsection B of this section.
- L. Upon implementation of this subsection as provided for in subsection M of this section and contingent upon the provision of appropriated funds designated for such purpose, each urban school district identified by the State Department of Education as having a high population of elementary grade students who are at-risk and in need of alternative education shall provide elementary level alternative education programs. The State Department of Education shall establish requirements for the programs. For purposes of this section, "urban school district" means a school district with an average daily membership of thirty thousand (30,000) or more.
- M. Implementation of subsections K and L of this section shall be delayed until the current expenditure per pupil in average daily attendance in public elementary and secondary schools in unadjusted dollars for the 1998-99 school year or any school year thereafter for Oklahoma, as reported by the National Center for Education Statistics annually in the Digest of Education Statistics, reaches at least ninety percent (90%) of the regional average expenditure for that same year, and funds are provided. For purposes of this subsection, the regional average expenditure shall consist of the current expenditure per pupil in average daily attendance in public elementary and secondary schools in unadjusted dollars for each of the following states: Arkansas, Colorado, Kansas, Missouri, New Mexico, Oklahoma, and Texas, averaged together. By January 1 of each year, the State Board of Education shall report whether or not the ninety-percent expenditure level has been reached based on information reported annually in the Digest of Education Statistics by the National Center for Education Statistics. Subsections K and L of this section shall be implemented on July 1 after the first January 1 report verifies that the ninety-percent expenditure level has been reached and funds have been provided for the specific purposes of this section. Discussion: Board President Robert Hill called the meeting to order at 8:30 a.m. with four board members present. Assistant Superintendent Gerrett Spears and Minutes Clerk Brook Keast were also present.

2. Swearing in of Burlington Board of Education Seat 4.

Discussion: Assistant Superintendent Gerrett Spears read the official results from the Alfalfa County Election Board and April Kisling was administered the oath of office for Board Seat 4.

Discussion: Attending as guests were Joe Granados, Alexander Harmon, Tyler Hill, Natalie Hill, Merritt Morgan and Jana Lindley

5. Student and staff spotlight

Discussion: Mr. Pedersen was not able to attend the meeting due to testing, but left notes to be read. Lindsey Morgan was the elementary teacher spotlight. "Mrs. Morgan does a great job as our 5th grade teacher. Her classroom provides an atmosphere in which students feel comfortable and eager to participate in the lessons. She encourages her students to achieve their highest ability. Mrs. Morgan uses a variety of instructional tasks which allows every student a chace to be successful. Mrs. Morgan goes above and beyond when it comes to supporting our students. She assists with the supervision of elementary track meets. These events often go well past the normal school hours. As you saw this past Monday, she was very instrumental in Purple Pride and was a key part of the athletic banquet. She spearheads the flower fund and collects donations from staff for graduation gifts. Mrs. Morgan is always willing to help out where needed. She will cover for other classes when needed. She represents the kind of dedication to our school that I think we can all appreciate. Mrs. Morgan is a very valuable member of staff here at Burlington."

Mr. Pedersen also left notes regarding the elementary student spotlight of the month, Merritt Morgan. "When a behavioral situation arises with students, I can always count on Merritt to be truthful and honest. Trustworthiness is such an important character trait to have. Merritt really emphasizes this trait to the fullest. He is also a great helper, as you saw at the athletic banquet, working behind the dessert table. Merritt does a great job representing the qualities we embrace here at Burlington." Merritt's teacher, Mrs. Hoggard, stated "I can always rely on Merritt to be trustworthy. Merritt is always thinking about the safety of himself and his classmates, making sure our doors are always shut. He works hard in class and is very responsible. He is a joy to have in class."

Assistant superintendent Spears stated Joe Granados was also a staff spotlight. Joe makes sure the facilities look good, especially prior to events, even if it makes him come in after hours. He doesn't complain even when asked to do jobs that aren't the greatest, like pulling carpet in rental houses and moving washers and dryers. This is a role that tends to go unnoticed until it hasn't been done, but he is appreciated tremendously. Spears states Joe always meets deadlines given, even if he has to work unconvential hours.

Alex Harmon and Tyler Hill were student spotlights for the JH/HS. Spears stated that Alex is a good kid. Alex spearheaded building the robot in this year's robotics competition. His grades are fantastic and his teachers love him. He has recently started podcast with friends. He is going to OU next year and majoring in engineering. He excels in representing Burlington. He is an excellent mentor for younger kid, especially in Skordle and Robotics. Spears stated Tyler Hill has recently achieved a high ACT score. Tyler's maturity level has increased immensely this year. He is becoming a leader for younger kids. One of Tyler's teachers, Mrs.

Lindley, states he has done everything she's asked him to, even though it's been a lot. She has assigned him many projects, requested he listen to endless podcasts on how to improve the ACT score, and reviewed numerous ACT questions.

Discussion: The board returned to the supterintendent office at 9:55 a.m. The school will take ownership of the new gym on May 1st. "That doesn't mean it's done as occupancy hasn't been granted yet. However, our insurance will kick in and we will be able to have more access per superintendent approval," stated Spears.

8. Principal Report

Discussion: Mr. Pedersen provided a written update for the board, which Mr. Spears read. Iowa Testing has been completed for 1st and 2nd grade. State testing will be finished this week. Big Ideas was chosen as the math curriculum for grades K-12th. A quote will be provided soon for the curriculum. The elementary schedule for FY25 had a change, adding the Gifted and Talented program and remediation. Summer Remediation notes went out last Friday. Mrs. Granados will be teaching the program this summer. June 3rd-13th from 8-11 a.m. Monday through Thursday will be the schedule. Summer Reading Program will be held on Tuesdays from 9-11 a.m. through the months of June and July. All OKTLE Focus plans have been completed by teachers. Teachers are submitting their curriculum and wants and needs lists for the next school year. They are also working on updating their classroom inventory for the end of the year. Upcoming dates include the Spring Music Program on April 29, Cherokee Elementary Track Meet (Grades 1-6) on April 30th, Tri-State (Grades 4-6) on May 1st, Burlington Elementary Track Meet (Grades 1-6) on May 2nd at 9 a.m., 6th grade field trip to Strataca on May 3rd, PK-2nd grade field trip to Hatfield Park on May 6th, K-2nd AR Reward at Graham's pond on May 7th, 3-6th grade AR reward at Cookie's Bowl on May 8th, Elementary Awards Assembly on May 9th at 8:30 a.m., and Teachers check out day with lunch on May 10th.

Spears states the high school awards program will be May 9th from 10-11 a.m. School will dismiss early on May 9th at 12:30 p.m. FFA state convention goers will leave on Monday, participating on Tuesday and Wednesday. The FFA banquet will be May 2nd at 5:30 p.m. 8th grade promotion is at 7 p.m. on May 9th with Marci Hyde speaking. High School graduation will be May 10th at 7 p.m. in the

auditorium. Sarah (Garvie) Wilbur will be the speaker. May 10th is teacher check out.

Kiefer Public Schools (KPS) has not had over ten students in an alternative setting for many years. If the waiver is denied we will contract with the nearest COOP. However KPS feels we can accomodate any student when the need presents itself.

This would pose a hardship for the district to provide transportation to and from their campus. We also feel like our students are best served locally. We currently serve 3 students.
- B. We currently offer an extended school day for the alternative education program. Our flexible schedule allows the program to start at 9:30-3:15; therefore, our students have more hours in the day to complete school work or we can offer them a flexible schedule to fit the student's needs. Our program allows more individual one-on-one instruction and assistance for the students.
- C. We have not participated in a coop previously. Yes, we have been granted this waiver in past years. We feel that being able to serve our students directly on campus allows for more opportunities for completion of credits and graduation. In past years, we have had students successfully complete their courses and graduate.



Our previous LEA will no longer be providing the service for our school. There are no schools in our county providing Alt Ed COOP services as an LEA. We are not aware of an LEA offering COOP services within 60 miles. If the waiver is denied, students would be traveling at least an hour to and from a provider. We do not project any Alternative Education students for the 2024-25 school year. If approved, 100% of any future Alternative Education students would benefit.

The district will have tutoring available for students up to one hour each day after school. We also will have bi-lingual tutors for students that need help in language development. We have a student counsel to aid in advisory for these potential students. We will utilize the Alpha Plus program, as well as many other programs to determine the students' status in learning objectives. Counseling will be available as needed. We have a food pantry and we are a part of the Food For Kids Program. Each student will have their own computer provided by the district and internet access, if needed. This would be the second year for the waiver. Learning achievement is monitored through periodic assessment and eventually end-of-year exams such as ACT or state exams, classroom grades, semester tests, and consults with Instructors. We were not sending any students to the COOP for the last several years, so there is no impact to the district.

Fargo-Gage Public School has participated in an Alternative Education COOP for many years with Arnett Public School being the LEA. We requested and received this waiver for the first time last year. We had not sent students to the COOP in Arnett for many years, so there is no impact on the district due to the waiver. The waiver is an important tool in case we need it in the future for students that may have that need. We continue to provide all of the supports such as tutoring, counseling, access to computers, and internet access. We build relationships with families to have a better understanding of student needs.



 - The Tishomingo School District provides a much needed service to numerous students each year through the Tishomingo Alternative Academy. The District serves students each year in the Alternetive Education Academy that otherwise would not achieve their of gradution and obtain a high school diploma. Tishomingo Schools is 34 miles from the closest Alternative Education Program that we would be able to coop with. This would create a burden on both the student and the District and greatly reduce our District's ability to serve some of our most challenged students. If the District's waiver request was denied we would with certainty experience a greater numbe of dropouts. The academy has served an average of 5% of our high school population in the past two years.
- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement. The District has employed a teacher with a master's degree to facilitate the alternative education academy along with a support posistion that provides tutoring in subject matter to students in the program. The District has also purchased a license to utilize the Edgenuity web-based curriculum to ensure a rigorous academic program. The District also staff members available for tutoring alt ed students in academic subjects. The District provides community based projects to teach students service learning, takes students on field trips to broaden and enrich their curriculum and cultural awareness. The District provides counseling and career based guidance through District employed counselors and career coordinators as well as counseling service provided by community counseling partners. We feel that we are better able to serve and hold students accountable by providing the alternative academy within the District where our students live.
- C. Have you participated in an alternative education coop previously? Have you been awarded this waiver before and what was the educational impact to the district: Results of the Statutory Waiver, i.e., effect on student performance levels, impact of plan on other sites in the district. Yes, the District has participated in an alternative education coop previously. The District serves as the LEA and has a coop agreement with Ravia Public Schools a K-8 district within 5 miles of Tishomingo Schools. Yes, the District was awarded a waiver for the 2023-2024 school year. The District serves serves more than 10 students annually, but can not guarantee that at least 10 students will be enrolled in the alternative education program at all times throughout the school year. The waiver has resulted in the District being able to provide service to students that are already struggling with earning sufficient credits and in several cases having attendance issues. The waiver has had an overall positive effect on the educational impact of our students and our graduation rates by meeting students' eduational needs within our District.

The District's alternative education allocation doesn't cover the cost of the program, but the District has committed to serving our students. The negative impact on the District's budget does not compare to the negative impact not providing the program would have on our students. When including the cost of transportation to and from an out of district coop and an increase in the drop out rate of students if the District were unable to facilitate an alternative education

program the cost of providing the program is certatinly worth the investment.

The Distict will use student ACT scores, graduation rates, and the school report card to evaluate the success of the program.

 - The Alternative Academy has been very benefical for our students. This past year we were able to graduate students from the program with one being an early graduate. Wilburton is requesting the waiver to continue offering the alternative school option for our students. A cooperative program would require more than one hour for daily transportation and would not be in the students best interest. If the waiver is not approved these students will likely drop out of school or continue to struggle in the regular education setting. We estimate that 5% of our students could utilize the alternative school at some point in the school year.
- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement. The students enrolled in the alternative education program will have the opportunity to come to school on a modified schedule. Students may arrive on or after 8:00 a.m. to complete their coursework. The learning platform will provide unlimited flexibility for our students to complete lessons in the alternative classroom or outside of school hours. Students will be enrolled in core and elective courses to complete graduation requirements. Participation in extra-curricular activities will be allowed to maintain student involvement in the total school experience. Counseling will be provided to students to streamline enrollment in proper coursework for graduation purposes.

These factors will assist in creating a positive image for our alternative school program within the community.

Students between the ages of 14 and 21 may apply to Wilburton Alternative School if they meet one or more of the following requirements:

- One or more years behind grade level
- Students who have dropped out of school
- Students who are married
- Students who are pregnant or parenting

Suspended or expelled students are not eligible during the term of the suspension or expulsion. Students who qualify for special education services are not usually eligible under special education mandates. Transfer students will not be accepted.

The two admission dates for Wilburton Alternative Academy are August and January. The only exceptions to this rule are those students that are referred by Wilburton High School and are still in compliance with Oklahoma Attendance laws for the current semester.

Students must fill out an application, go through an interview and then may be accepted to the program. If the student is currently enrolled in a school, they should NOT withdraw from school until they have been accepted to Wilburton Alternative School. Acceptance and enrollment at Wilburton Alternative School is based on the above criteria, the interview, and on availability of space. There is often a waiting period (after returning the application) before an interview is scheduled. There is no guarantee a student will be accepted to the program.

If enrolled in Wilburton Alternative School, the student will be expected to attend school promptly everyday and make progress in earning academic credits for graduation each semester.



We are requesting a 3 year waiver, because we are a small rural school that has struggled to afford a successful coop or the means to run a full-time program due to number of students that need an alternative school setting. We sent two kids to Tupelo this past year in a coop which is over 30 miles away. The cost to pay Tupelo and the two hours each day to take the kids back and forth is not effecient or affordable to our district. We would love to have the flexibility to serve our students internally with the staff we already have. We average bewtween 2-3-students over the years.

By our students staying on campus to receive the education needed for graduation, they can still continue to be a part of the student body, which allows them to grow better socially and emotionally. It will also be easier and more accessible for these students to participate in extra-curricular activities that we provide. They will also be receiving instruction from teachers they know and trust. The closest neighboring school that could potentially co-op with us is eighteen miles one-way. None of our neighboring schools would have ten or more students even if we did a co-op. The geographic distance and small student enrollment make an Alternative Education Co-Op not the most viable, economic way to meet the needs to alternative ed students.

 - Our plan includes using online courses via Edgenuity, Imagine Learning, and in-person classes we already offer when feasible. The students will be supported through teachers, counselor, administrators, and mentors to successfully graduate and become prepared for life.

I feel as though travel is the number one reason for this disappointing level of success. Educating our own students has decreased our number of students being home schooled, transferring to virtual schools or failing to complete graduation requirements. We are able to closely monitor attendance as will students meeting the class time requirements.



- A. Reason for the Deregulation request. Please include how your students would benefit from this deregulation, what alternative means will have to be employed, and negative effects on your alternative education population if your waiver was to be denied.
 It is cost prohibitive to participate in an alternative education coop. The closest possible district is 10 miles away. If the waiver is denied, our district would have to employ a staff member to oversee the alternative education program, which would be cost prohibitive for the district as well. Additionally, due to our rural location, it is difficult for our district to find teachers and staff to fill necessary positions. Over the past three years, zero percent of our student population has been in need of a an alternative education program.
- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your alternative education program, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and the result of the previous years alternative education audit.
 The low number of students in our District Needs Assessment indicates we would have a minimal number of students, if any, who need alternative placement. We have been on an alternative education waiver for the past three years. We utilize benchmark testing for all students grades K-11 using NWEA to monitor student progress and implement intervention strategies if needed. ACT and NWEA data are analyzed by teachers and administration quarterly. We have an additional part time counselor who will be available to assist in meeting the students' social-emotional and academic needs. Our graduation rate over the previous three years is 96%. The vast majority of those dropouts have been ones that moved out-of-state.
- C. Educational impact to the district: Results of the Statutory Waiver, i.e., effect on student performance levels, and predicted graduation rate.
 Yes, Hooker Public Schools has previously participated in an alternative education coop. We have used the waiver for the past three years. During that three year period, we have implemented benchmark testing using the NWEA. Using the NWEA data, we have been able to implement interventions for students reducing our class failure rate drastically. Over the past three years, there was not a need for an alternative education program. Our graduation rate for this year is 97%.

D. Timeline: Please submit class schedule, calendars, assessment forms and other attachments as necessary, or described in instructions. A waiver/deregulation can be granted for up to 3 years. (Please see instructions for additional requirements)
When we had an alternative education program, prior to the previous 3 years, the class schedule was from 8:00am to 12:38pm. There is presently no alternative education schedule.

- E. Any financial impact to the District (positive or negative) for the proposed waiver/deregulation? If positive please describe where the available would be reallocated.
 A grant allocation is no longer available for alternative education. As a rural school district in the Panhandle, it would be cost prohibitive for us to implement and monitor a program that is not needed. If the waive is denied, our district would be forced to employ a staff member to oversee the alternative education program which would, again, be cost prohibitive to the district. Additionally, due to our rural location, it is difficult for our district to find teachers and staff to fill necessary positions and to meet the additional requirements of running an alternative education program
- F. Describe method of assessment or evaluation of effectiveness of the plan both for staff and students, I.E., TLE, ACT scores, graduation rates, RSA, School Report Card, etc.
 Again, we have been on an alternative education waiver for the previous three years. During that time we have been able to use benchmark assessments with NWEA, student interventions to reduce failure rates, and employ an additional part-time counselor to meet the needs of students.

 - Given our small size, our alternative education program will certainly serve fewer than 10 students. We believe that we are better able to meet the alternative education needs of our students on-site rather than transporting a great distance to a neighboring school system. The closest school system with an alternative education cooperative is more than 30 miles. If our waiver is denied, given the distance to the nearest alternative education cooperative, any alternative education students that we might have would more than likely have to remain in the regular education setting, which could have a negative impact on their academic success. If approved, 100% of participating students would benefit.
- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement.

 We believe that we can better serve our students locally. We have been in a cooperative in the past and have never had any students participate in the program. The main reason for this is due to the distance (45 miles one-way). By serving our own students, we will be able to provide a positive and familiar educational setting. Our alternative education program will use an on-line curriculum along with classroom instruction. We will also provide integration with regular classes to ensure our students are involved in school activities.

C. Have you participated in an alternative education coop previously? Have you been awarded this waiver before and what was the educational impact to the district: Results of the Statutory Waiver, i.e., effect on student performance levels, impact of plan on other sites in the district. We have previously participated in an alternative education cooperative; however, we have never had any students participate in the program. The distance of 45 miles one-way has proven to be prohibitive. We applied for and received a Statutory Waiver for the 21-24 school years. No students were served by our local program during that time; therefore, there has been no impact. By having our own local program, we believe we will be better able to design the program to meet the specific needs of our students.

Students attending alternative education would follow our regular school calendar (see attached). Program times would be 8:20 AM to 12:32 PM, Monday through Friday, with students being able to participate in the regular school breakfast and lunch programs.

Financial impact to our district would be related to saving the transportation costs associated with sending students a great distance to another school district. These savings could then be used to fund our local alternative education program in the areas of curriculum, supplies, and instructional materials.

 - We are asking for a waiver of 70 O.S. § 1210.568 COOP Agreement When a public school wants to serve fewer than 10 students in the alt ed program instead of COOPing with other districts. Our school is a large district encompassing the southern half of Washington County. Our students would have to drive to Barnsdall, Bartlesville, or Collinsville to attend an alternative school without this waiver. We currently only have 7 students in our alternative program, but they are students who are succeeding in the alternative setting. Our alternative program is very mobile. This number changes constantly. Without this program these students would be classified as dropouts.

 - We currently use Edgenuity as well as a certified core teacher for instruction within our alternative education program. This allows the students to work at their own pace beyond their academic day on campus. Many of our students are able to be gainfully employed during the day and attend the alternative sessions in the evening. The program is similar to our virtual program, but requires students to be on campus in addition to their virtual interaction.

 - We have not participated in an education coop for this program previously. Many of our alternative students elected to go virtual to avoid the need to report to campus.
