SUBJECT: Deregulation for Library Media Specialist Certificate Exemption

Section 42.8. Requirements for Exemption.

- A. A school district may develop an educational improvement plan which includes exemption for the educational-related statutory requirements set forth in subsections C of this section and State Board of Education rules for the school district, a school site or any program, grade level, consortium of schools or school districts or other group within the school district. The board of education of the school district shall, through adoption of a resolution, approve the plan prior to application being made to the State board of Education.
- B. Each educational improvement plan approved by the State Board of Education shall include the following components:
 - 1. A description of the educational benefits to be derived;

2. A definition of the standards of the plan;

Development of definitive work products, such as site improvement plans and progress reports;

4. Demonstration of collaboration by teachers, administrators, higher education representatives, students, parents/families, and the community;

5. Development and the use of an assessment mechanism to determine progress in meeting the goals and objectives of the plan;


6. Development of an in-service training plan to be provided to personnel at the site who will participate in the project;

7. Report on the results of the plan to the State Board of Education and provision of appropriate technical assistance to other school districts and the State Department of Education as required; and

8. Explanation of how the plan will affect other schools, program or sites in the district.

C. Each educational improvement plan shall include a list of the specific educational-related statutory requirements and State Board of Education rules the school district is requesting an exemption from and why each exemption is necessary to success of the plan. The school district shall not be granted an exemption from federal educational-related requirements. A school district may request and exemption from any statutory requirement or State Board of Education rule not related to bilingual and special education programs, health and safety provisions, school finance, State Aid, pupil formula weights, teacher salary and teacher retirement, the Oklahoma School Testing Program, the Oklahoma Educational Indicators Program and the teacher preparation, examination, licensure, certification, residency and professional development system. The State Board of Education may grant district-wide exemptions from certification requirements for Library Media Specialist to districts experiencing a shortage in this area. The State Board of Education may grant an exemption from certification requirements for superintendents to any district with an unweighted average daily membership over twenty-five thousand (25,000). A. Reason for the waiver/deregulation request (be specific).

70 O.S 2-126 Library Media Specialist/Waiver Certification Only- Teacher attending college/university to obtain Library Media Specialist certification.

Darla Tanner will be in her first year as our Elementary Librarian. We are asking for a 3 year waiver of Library Media Specialist from the SDE. Mrs. Tanner is enrolled at Northeastern State University with 7 hours for the Fall of 2019 and her expected graduation date is May 2021.

Mrs. Tanner will contiue to work closelywith her mentor, Brandi Minor, our high school Library Media Specialist and our Elementary Principal, Honesti Williams.

B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students and learning achievement.

Mrs. Tanner will be able to support teachers in raising reading achievement of all elementary students. Mrs. Tanner has taught first grade and was the lead teacher. Her expertise in teaching reading will contribute to the success of our students in the library.

Mrs. Tanner has helped with RTI with 1st students, and will put that expertise to work on a daily basis with all grade levels. Mrs. Tanner is excited about helping teachers in their everyday use of curriculum, to help increase our students reading levels.

C. Educational impact to the district: Results of the Statutory Waiver/Deregulation, i.e., effect on student performance levels, impact of plan on other sites in the district.

Mrs. Williams, elementary principal, has been very pleased with the leadership and success Mrs. Tanner has had in the classroom. Mrs. Williams believes Mrs. Tanner will build a program that will be helpful to teachers, and increase reading levels of all elementary students.

Mrs. Tanner's ability to build relationships with students will allow her to inspire students to love reading.

D. Timeline: Please submit class schedule, calendars, assessment forms and other attachments as necessary, or described in instructions.

A waiver/deregulation can be granted for up to 3 years. (Please see instructions for additional requirements)

Mrs. Tanner is currently enrolled at Northeastern State University in the Library Media and Information Technology, M.S. program. She will have completed 13 hours of library courses by May 2020. Mrs. Tanner plans to have her certification by May 2021.

Each semester a copy of course enrollment will be obtained to prove continuance and completion towards certification until all course requirements are met.

Upon completion of coursework, proof of passage of required certification tests will be obtained from Mrs. Tanner.

E. Any financial impact to the District (positive or negative) for the proposed waiver/deregulation.

There is no financial impact on the district with this move. This move was made because it was in the best interest of our students. Mrs. Tanner is a very passionate and caring teacher that relates well to her students. We feel she is the best candidate for the job.

F. Describe method of assessment or evaluation of effectiveness of the plan.

The high school librarian will serve as the mentor for Mrs. Tanner during the waiver process. They will collaborate on all book selections, activities, library policies, and procedures. Mentor teacher will collaborate with the elementary principal to ensure the library is following proper protool.

The elementary principal and mentor teacher will meet bi-weekly with Mrs. Tanner to give feed back on her job performance. Recommedations will be given to Mrs. Tanner to help her grow in her position. Mrs. Tanner will also be attending workshops, such OTA conference, ALAN conference, and AASL/ALA mid-winter conference to increase her knowledge of becoming a Library Media Specialist. Salina Public Schools will report annually on Mrs. Tanner's progress towards completion of required coursework and tests. This tracking will be reported to the Salina School Board and the State Superitendent, and State School Board Members until completion by Mrs. Tanner.

A. Reason for the waiver/deregulation request (be specific).

Mrs. Fitzgerald has been working under a previous waiver at Tulsa Public Schools. She is very close to finishing her Master's degree in Library Media Science. She will finish this school year and will apply certification. We had no other applicants who were qualified for this job when it was posted.

B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students and learning achievement.

The position of Library Media Specialist is extremely beneficial to the students in our building. The librarian plays an important part in the development of reading, language, and technology based skills, and she is teaches lessons that incorporate both academics and the love of reading. Mrs. Fitzgerald's experience working as both a public school librarian and the librarian of a public library will allow her to provide a well-rounded, highly engaging experience to all our students.

C. Educational impact to the district: Results of the Statutory Waiver/Deregulation, i.e., effect on student performance levels, impact of plan on other sites in the district.

Mrs. Fitzgerald will serve two students in our district, both the Upper Elementary and the Middle School. This extends her influence to over 700 students. For these students, she will be teaching both reading and language arts skills, and demonstrating how to apply those skills in the world of media and technology. Mrs. Fitzgerald will be teaching a portion of the OAS Language Arts skills in her weekly library classes and this will help emphasize and strengthen the teaching students receive in their classes.

D. Timeline: Please submit class schedule, calendars, assessment forms and other attachments as necessary, or described in instructions. A waiver/deregulation can be granted for up to 3 years. (Please see instructions for additional requirements)
Mrs. Fitzgerald will see all elementary classes for 30-45 minutes each week for instruction in library and language arts skills. She will also instruct middle school students during classes scheduled on an individual basis by the teachers. She is responsible for the Gifted and Talented program at the Upper Elementary. In addition to teaching her classes, she will maintain and operate the library for the Upper Elementary and Middle School on a full-time basis.
E. Any financial impact to the District (positive or negative) for the proposed waiver/deregulation.
The district will pay Mrs. Fitzgerald according to the board approved salary schedule.

F. Describe method of assessment or evaluation of effectiveness of the plan.

The TLE system will be used to evaluate the effectiveness of Mrs. Fitzgerald's teaching. In addition, data will be gathered regarding library usage, number of books checked out, etc. to determine if she is effectively enticing students to visit and check books out.

To Whom It May Concern:

I began working on my Master's Degree in Library Science from the University of North Texas in August of 2017. I have currently completed 21 of the 36 hours required. I have a 3.4 GPA. I will begin classes again on August 19th and I am currently doing my Practicum through Tulsa Community College Library. By May of 2020 I will have my Practicum completed and I will have at least 27 hours finished. My last 9 hours will require some travel back to Texas, and I am going to do as much of that as I can over the Summer of 2020. I will complete my Master's Degree no later than May of 2021. I am hoping for December of 2020, but I may need the Spring semester in order to finish well. I am working as I go through school, and I want to maintain a solid GPA and not over extend myself. The University of North Texas allows for five years to finish from the time you begin, and I will finish in four.

I was the school librarian for Gilcrease Elementary from March 2018 – May 2019. Gilcrease was part of Tulsa Public Schools. It has been consolidated with another school. I am currently hired to be the school librarian for Oologah-Talala Upper Elementary.
