

# How to send a Student Attendance Summary Record

## **Example 1: (FQSR Response WITH a gap in enrollment)**

- 1. Student A has a <u>StudentSchoolEnrollment.EntryDate</u> of August 12, 2019, and a <u>StudentSchoolEnrollment.ExitDate</u> of August 16, 2019.
  - Between August 12, 2019, and August 16, 2019, there were 5 <u>instructional</u> days that counted towards student attendance.
  - The student was not eligible for transportation and was present for all 5 days.
- 2. Student A has a <u>StudentSchoolEnrollment.EntryDate</u> of August 27, 2019, and a <u>StudentSchoolEnrollment.ExitDate</u> of August 30, 2019.
  - Between August 27, 2019, and August 30, 2019, there were 4 instructional days that <u>counted towards student attendance</u>.
  - o The student was eligible for transportation and was present for all 4 days.

Because this student exited early, it is not expected to receive an attendance summary for the full year.

# Example 2: (FQSR response WITHOUT a gap in enrollment) and (ASR response WITHOUT a gap in enrollment)

- 1. Student B has a <u>StudentSchoolEnrollment.EntryDate</u> of August 18, 2019, and a <u>StudentSchoolEnrollment.ExitDate</u> of May 21, 2020.
  - Between August 18, 2019, and May 21, 2020, there were 172 <u>instructional</u> days that counted towards student attendance.
  - o This district's first nine weeks ends on October 17, 2019.
  - o The student was eligible for transportation and was present for all but 3 days.
