Minutes of the Special Meeting of the Statewide Virtual Charter School Board September 17, 2014

CALL TO ORDER AND ROLL CALL

John Harrington called the Statewide Virtual Charter School Board special meeting to order at 1:00 p.m. and welcomed everyone to the meeting. Ms. Cheadle called the roll and ascertained there was a quorum.

PLEDGE OF ALLEGIANCE, OKLAHOMA FLAG SALUTE, AND MOMENT OF SILENCE

John Harrington led Board Members and all present in the Pledge of Allegiance to the American Flag, a salute to the Oklahoma Flag, and a moment of silence.

OPENING COMMENTS

John Harrington thanked Board Members for attending the special meeting.

ADMINISTRATION

Interim Budget Authorization Approved

John Harrington presented an interim budget authorization request for the Statewide Virtual Charter School Board (SVCSB). Currently the SVCSB does not have staff to administer the funding at this time therefore; the State Department of Education will assist through December 31, 2014. Mr. Harrington said he and Joel Robison, Chief of Staff to Superintendent Barresi, have discussed accountability concerns and recommended Mr. Robison as the "designee" authorized to oversee SVCSB expenditures until the Executive Director is hired.

Board Members reviewed the \$1.1 million budget for 2015-2016, office space provision, and budget flexibility.

Debbie Long made a motion to adopt the budget authorization request as presented and designate Joel Robison as the oversight authorizer. Denise Floyd seconded the motion. The motion carried with the following votes: Mr. Harrington, yes; Ms. Long, yes; Ms. Vreeland, yes and Ms. Floyd, yes.

Job Descriptions for the Positions of Executive Director and Administrative Assistant for the Statewide Virtual Charter School Board (SVCSB) Approved

Debbie Long presented a revised draft description of the Executive Director and Administrative Assistant positions for the SVCSB. John Harrington said there was a minor edit to change the Administrative Assistant description to an Executive Assistant.

Denise Floyd made a motion to approve the timeline to hire SVCSB staff and job search strategy. Debbie Long seconded the motion. The motion carried with the following votes: Mr. Harrington, yes; Ms. Long, yes; Ms. Vreeland, yes; and Ms. Floyd, yes.

SVCSB Membership to the Oklahoma National Association of Charter School Authorizers (NACSA) Approved

Debbie Long presented a request to apply for membership to the Oklahoma National Association of Charter School Authorizers (NACSA) and membership fee of \$500. Membership includes access for all board members and staff.
