

**RULE IMPACT STATEMENT  
TITLE 210. STATE DEPARTMENT OF EDUCATION**

**CHAPTER 10. SCHOOL ADMINISTRATION AND INSTRUCTIONAL SERVICES  
SUBCHAPTER 3. CHILD NUTRITION PROGRAMS**

- a. **What is the purpose of the proposed rule change?**  
The purpose of the proposed changes to the rules at 210:10-3-51, 210:10-3-71, and 210:10-3-91 revise the rules to incorporate State Health Department food handling regulations and USDE regulations pertaining to child nutrition programs. The amendments to the rule are necessary to avoid conflicts with federal, state, and local statutes and regulations pertaining to food handling and to implement provisions of the newly enacted Josephine Meade Anti-Hunger Act at 56 O.S. § 163.3 (HB 1418), which directs the State Department of Education to promulgate rules to prevent food waste in public school cafeterias and to develop policies for redistribution of leftover foods to students in need.
- b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**  
The proposed changes will affect public school students and their parents/legal guardians, as well as public school districts and public schools.
- c. **What classes of persons will benefit from the proposed rule change?**  
The proposed changes will benefit public school students and their parents/legal guardians, as well as public school districts and public schools.
- d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**  
The agency does not anticipate any economic impact upon affected classes of persons or political subdivisions as a result of implementation of the proposed rule change at this time.
- e. **What is the probable cost to the agency to implement and enforce the proposed rule change?**  
The agency does not anticipate any cost to the agency to implement and enforce as a result of the proposed change in the rule at this time. Additional record keeping, if any, will be performed by existing staff.
