

General Education Compliance Symbols

	Student is not eligible for any type of special education.
	This compliance symbol displays for any student for which a discontinuation of referral or parent consent denial occurred. The student has returned to the general education population.

Special Education Compliance Symbols

	The student is fully compliant with all IEP / ISP / IFSP and Eligibility requirements.
	The student is Eligible and has an IEP / ISP / IFSP and will soon require that a new IEP / ISP / IFSP be written.
	The student is Eligible and has an IEP / ISP / IFSP, but is now past due to have a new one written and is now out of compliance.
	The student has recently transferred into this school system and will soon require that a new IEP / ISP / IFSP be written.
	The student has recently been re-activated in this school system and will soon require that a new IEP / ISP / IFSP be written.
	The student has been determined Eligible for IFSP or Special Education and will soon require their re-evaluation.
	The student has been determined Eligible for IFSP or Special Education but is past due for their re-evaluation and is out of compliance.
	Once the student has turned 6 years old and has an entrance date of greater than 180 the symbol will turn red to indicate the information is past due.
	Six months prior to the child's 6th birthday a question mark will appear as a reminder the ECE data is required within 6 months
	Student has been referred (and may have Parental Consent to Evaluate). The student will soon need their initial Eligibility determination completed.
	Student has been referred (and may have Parental Consent to Evaluate). The student is now past due to receive their initial Eligibility determination and is out of compliance.
	Student will soon require an Evaluation.
	Student is past due for an Evaluation.
	Student has been referred for reevaluation. The student is coming close to requiring further action (i.e. they are in a 'warning' state).
	Student has been referred for reevaluation. The student has not received necessary action and is now out of compliance.

Section 504 Compliance Symbols

	The student is fully compliant with all Section 504 Plan and Eligibility requirements.
	The student has a Rejected Section 504 Plan or Section 504 Eligibility and it has been over a set period of time after the rejection.
	The student is Eligible and has a Section 504 Plan and will soon require that a new Section 504 Plan be written.
	The student is Eligible and has a Section 504 Plan, but is now past due to have a new one written and is now out of compliance.
	The student has been determined Eligible for Section 504 and will soon require their 3 year re-evaluation.
	The student has been determined Eligible for Section 504 but is past due for their 3 year re-evaluation and is out of compliance.
	Student has been referred for Section 504 (and may have Parental Consent to Evaluate). The student will soon need their initial Eligibility determination completed.
	Student has been referred for Section 504 (and may have Parental Consent to Evaluate). The student is now past due to receive their initial Eligibility determination and is out of compliance.
	Student has been referred or is eligible for Section 504, but will soon require Parental Consent to Evaluate.
	Student has been referred or is eligible for Section 504, but is past due to receive Parental Consent to Evaluate. The student is now out of compliance.
