#### CALL TO ORDER AND ROLL CALL

Superintendent Barresi called the State Board of Education special meeting to order at 9:00 a.m. and welcomed everyone to the meeting. Ms. Isenhour called the roll and ascertained there was a quorum.

#### STATE SUPERINTENDENT

#### Recognition of Alyson Glass as winner of the 2013 Bob Costas Grant for the Teaching of Writing

Superintendent Barresi introduced and congratulated Ms. Alyson Glass, English and Language Arts teacher and Chair of the English Department, Geronimo Public Schools, Geronimo, Oklahoma, on receiving the 2013 Bob Costas Grant for the Teaching of Writing. Ms. Glass will use the grant award to introduce her students to the world of professional writing through activity workshops and organize a creative writing club that publishes a literary magazine.

#### STATE SUPERINTENDENT

#### **Information from the State Superintendent**

Superintendent Barresi thanked Board Members for attending the special Board meeting on August 12, 2013, to approve donated items for Project Meet the Need. Volunteers and organizations throughout the United States have provided and distributed supplies and book donations to many schools. It is the beginning of the school year and we wish all the teachers well.

Superintendent Barresi attended the first day of school at Two Lakes Elementary in the Putnam City School District along with Dr. Rhodes who is the new superintendent. Two Lakes Elementary is located in a high poverty area within the district and has a high transient population. The leadership and staff are to be commended on their organized efforts in working together, focus/vision for children, and unrelenting devotion to their students. #### **ACADEMIC AFFAIRS**

#### Office of Accountability and Assessments

Report on the HumRRO Study and discrepancy review analyzing the effect of the online testing interruptions that occurred on April 29-30, 2013

Ms. Maridyth McBee, Assistant State Superintendent, Office of Accountability and Assessments, reported the results from the Human Resources Research Organization (HumRRO) independent study on the impact of the disruptions on student test scores during the server outage experienced during the spring 2013 testing window. Ms. McBee said Dr. Art Thacker, HumRRO, was scheduled to present the report summary but due to the meeting time change could not reschedule his flight. Dr. Thacker is willing to return should the SBE desire. Ms. McBee reviewed the HumRRO report summary and conclusion.

This was a report only and no action was required.

## Report on the Department's response to the HumRRO Study and discrepancy review

Ms. McBee presented a report on the State Department of Education (SDE) response to the HumRRO study recommending retaining all scores of the students who tested on April 29 and 30 and also scored proficient and advanced. The SDE will not report scores for those students who scored limited knowledge or unsatisfactory. Those students will retake end of instruction (EOI) tests, and students in 6 through 8 grades will not have a score for this year's test.

An issue with discrepancies occurred partly as a result of the interruptions but did not have to do with the exact same study nor studies by HumRRO. When the student raw scores and summary scores from the comprehensive two week report were received, we found they differed. The second day disruption was a major impact. On Tuesday in their haste to get the system ready for participation, CTB did not perform a final check. As a result, when CTB received the scores back for processing, a set of scores was deleted making the raw score correct and the two week score depressed. Ms. McBee reviewed the steps for student scoring and options, CTB testing data verification, and reports.

This was a report only no action was required.

#### **Office of Educator Effectiveness**

#### **Update on Teacher and Leader Effectiveness (TLE)**

Dr. Kerri White, Assistant State Superintendent, Office of Educator Effectiveness, presented a report on the teacher and leader effectiveness system purpose/theory of action. Ms. White reviewed educator/research student achievement factors, SDE leadership, professional development and learning opportunities; conference updates, TLE Commission activity; UPD value-added vendor, stakeholders; and Office of Educator scheduled activity/opportunities.

## Achieving Classroom Excellence test exemption scores to implement provisions of Senate Bill 559 Approved

Ms. Melissa White, Executive Director, Counseling/ACE, presented a request to exempt cut scores on alternate tests for the Oklahoma ACE end-of-instruction examinations in order to meet ACE graduation requirements per Senate Bill 559.
