Description of Services

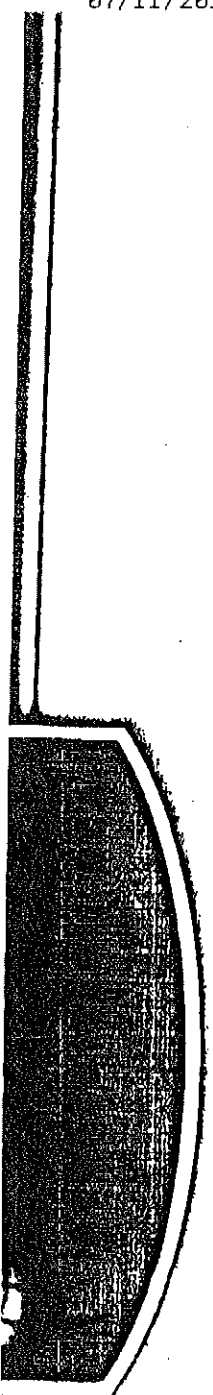
Special Care is committed to offering best practices in education and therapeutic intervention for children of all abilities, ages 6 weeks to 21 years.
